

ORDINANCE NO. 1201.01

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STACY TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, this territory abuts upon the corporate limits of the city at the southerly boundary thereof and is deemed to be urban or suburban in character; and

WHEREAS, this territory is owned in fee by the city;

The city council of Stacy ordains:

Section 1. Territory annexed. The corporate limits of the city of Stacy are hereby extended to include property now owned by the city and described on Exhibit A attached hereto and made a part hereof.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Minnesota Secretary of State, the Chisago County Auditor, the Clerk of the Town of Lent, and the Minnesota Municipal Board.

Section 3. Effective date of Annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.

That part of the South Half of the Southeast Quarter of Section 32, Township 34 North, Range 21 West, Chisago County, Minnesota, described as follows:

Commencing at the southwest corner of the Southeast Quarter of the Southeast Quarter; thence easterly, along the south line of the Southeast Quarter of the Southeast Quarter, a distance of 33 feet to the point of beginning; thence northerly, parallel with the west line of the Southeast Quarter of the Southeast Quarter, a distance of 700 feet; thence westerly, parallel with the south line of the South Half of the Southeast Quarter, to the center line of Forest Boulevard (also known as County Road No. 30, formerly known as Trunk Highway No. 61); thence northerly, along said center line, to the north line of the South Half of the Southeast Quarter; thence easterly, along said north line, to the easterly right-of-way line of Forest Boulevard; thence southerly, along said easterly right-of-way line, to the south line of the North 50 feet of the South Half of the Southeast Quarter; thence easterly along said South line, to the West line of the Southeast Quarter of the Southeast Quarter; thence northerly, along said west line, to the northwest corner of the Southeast Quarter of the Southeast Quarter; thence easterly, along the north line of the Southeast Quarter of the Southeast Quarter, to the west line of the East 830 feet of the Southeast Quarter of the Southeast Quarter; thence southerly, along said west line, to the south line of the Southeast Quarter of the Southeast Quarter; thence westerly, along said south line, to the point of beginning.

AND

That part of the North Half of the Southeast Quarter of Section 32, Township 34, Range 21, Chisago County, Minnesota, described as follows: Beginning at the East quarter corner of Section 32; thence West along the East-West quarter line 292.5 feet to point of beginning; thence South 1,261.5 feet; thence South 17 degrees 21 minutes East 56.5 feet, more or less, to the South line of the North Half of the Southeast Quarter; thence West along the South line 1,095 feet to the Easterly right-of-way line of Highway 61; thence Northerly along the Easterly highway right-of-way line 862 feet to a point distant 458 feet Southerly of the East-West quarter line of Section 32 as measured along the Easterly highway right-of-way line; thence Easterly parallel with the East-West quarter line 240 feet; thence Northerly parallel with the Easterly right-of-way line of Highway 61, 258 feet; thence Easterly parallel with the East-West quarter line 413.4 feet; thence Northerly parallel with the Easterly right-of-way line of Highway 61, 200 feet to a point on the East-West quarter line 653.4 feet Easterly of the point of intersection of the East-West quarter line with the Easterly right-of-way line of Highway 61; thence Easterly 501 feet, more or less, to the point of beginning.

Subject to Forest Boulevard and 300th Street.


That part of the Southeast Quarter of the Southeast Quarter of Section 32, Township 34 North, Range 21 West, Chisago County, Minnesota, described as follows:

Commencing at the southeast corner of said Section 32; thence N 3°34'45"W, assumed bearing, along the east line of said Section 32, a distance of 500 feet to the point of beginning; thence S 86°25'15"W, 500 feet; thence N 3°34'45"W, 868 feet to the point of intersection with the north line of said SE $\frac{1}{4}$ -SE $\frac{1}{4}$ of Section 32; thence S 89°05'E, along said north line, 131.3 feet to the point of intersection with the westerly line of the Minnesota Conservation Department Public Hunting Grounds, as recorded on Microfilm No. 112353; thence S 16°40'50"E (recorded as S 17°21'E), along said westerly line, a distance of 215 feet; thence S 62°36'50"E (recorded as S 63°17'E), continuing along said westerly line, 373.6 feet to the point of intersection with the east line of said Section 32; thence S 3°34'45"E, along said east line, 456.1 feet to the point of beginning, containing 7.5 acres, more or less.
