

ORDINANCE NO. 660

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BAYPORT TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, this territory abuts upon the corporate limits of the city at the northern and western boundary thereof and is deemed to be urban or suburban in character; and

WHEREAS, this territory is owned in fee by the city;

The city council of Bayport ordains:

Section 1: Territory annexed. The corporate limits of the city of Bayport are hereby extended to include the unplatted property described as follows now owned by the city:

The North 900 feet of the South West Quarter (SW 1/4) of the North East Quarter (NE 1/4) of Section Ten (10), Township Twenty Nine (29), Range Twenty (20), Washington County, Minnesota, as measured at right angles to the North line of the South West Quarter (SW 1/4) of the North East Quarter (NE 1/4) of said Section Ten (10).

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the Washington County Auditor and the Minnesota Municipal Board.

Section 3. Effective date of annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.










