That your Petitioners verily believe that said lands are considered as property to be subject to municipal government, and that said annexation would be to the best interests of the municipality and of the lands described in Exhibit "A" attached hereto and hereby made a part hereof.

That the undersigned make this Petition to the Honorable City

Council of the City of Chaska in accordance with and pursuant to Minnesota Statutes, Section 414.033, and pray that the City Council of the City of Chaska will grant this Petition, and will take any and all action necessary for annexation of the above described lands under the authority granted by said Section.


