Gentlemen:

The Town Board of Rollingstone Township, Winona County hereby requests the withdrawal of their objection to the annexation of the following described property to the City of Goodview.

A parcel of land containing 1.157 acres in the Southeast corner of the Southwest Quarter (SE 1/4 of SW 1/4) of Section Twelve (12), Township One Hundred Seven (107) North, Range Eight (8), West of the Fifth Principal Meridian, Winona County, Minnesota, and more particularly bounded and described by lines as follows, to-wit:

Beginning at the South Quarter post of said Section Twelve (12), Township One Hundred Seven (107), Range Eight (8) and running thence North along the North and South Quarter line of said Section a distance of 156 feet to the Southwesterly line of the Public Highway known as U.S. Highway Number 61; thence North 51 degrees 45 minutes West along said Southwesterly line of said Public Highway a distance of 163.16 feet, thence South 35 degrees 30 minutes West 321 feet to the South line of said Section; thence East and along said South line 314 feet to the point of beginning.

The East Thirty-three (33) feet of the above described land being a cartway containing .127 of an acre.

Excepting therefrom a parcel of land described as follows, to-wit:

Beginning at the Southeast corner of said Southeast Quarter of Southwest Quarter (SE 1/4 of SW 1/4) of Section Twelve (12), Township One Hundred Seven (107), Range Eight (8); thence North along the North and South Quarter line of said Section, a distance of 50 feet; thence at right angles West a distance of 102.5 feet; thence South 35 degrees 50 minutes West a distance of 62.5 feet to the Section line; thence East along said Section line a distance of 136.3 feet to the place of beginning - the East Thirty-three (33) feet of said described parcel of land being subject to the right of way of existing cartway.
