ORDINANCE NO. 2750

AN ORDINANCE RELATING TO ANNEXATION; ANNEXING TO THE CITY OF ROCHESTER A PORTION OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 4, TOWNSHIP 106 NORTH, RANGE 14 WEST, OWNED BY THE CITY OF ROCHESTER.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

Section 1. The Common Council of the City of Rochester has initiated the annexation of the following described lands located in Rochester Township, Olmsted County, Minnesota:

That part of the Southwest Quarter of the Northeast Quarter of Section 4, Township 106 North, Range 14 West, Olmsted • County, Minnesota, and of Lots 27 and 28, Hillcrest Subdivision, according to the plat thereof on file at the County Recorder's Office, Olmsted County, Minnesota, described as follows:
