

ORDINANCE NO. 236

AN ORDINANCE RELATING TO THE ANNEXATION
TO THE CITY OF MORA OF CERTAIN LANDS SITUATED IN ARTHUR
TOWNSHIP, KANABEC COUNTY, MINNESOTA

The City of Mora does ordain:

Section 1: That pursuant to the provisions of M.S.A. 414.033, Subd. 2 and upon a finding by the City Council that such properties presently owned by the City of Mora, Minnesota and therefore are deemed to be urban or suburban in character for the purpose of the Mora Municipal Waste Water Treatment Plant, the following described lands are hereby annexed by the City of Mora and shall henceforth be included within and be a part of the corporate limits of the City of Mora, Minnesota, to-wit:

Track 1

That part of the Northeast Quarter of the Northwest Quarter and the Northwest Quarter of the Northeast Quarter (North of Railroad right-of-way) of Section 15, Township 39N, Range 24W, Kanabec County, Minnesota.

19.8 Acres
Owned by the City of Mora

Track 2

That part of the East half of the Southeast Quarter of the Southwest Quarter of Section 10, Township 39N, Range 24W, Kanabec County, Minnesota.

20.34 Acres
Owned by the City of Mora

All of said lands being subject to all easements, roadways, and restrictions of record.


Section 2: All ordinances and portions of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

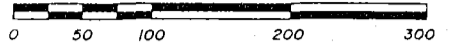

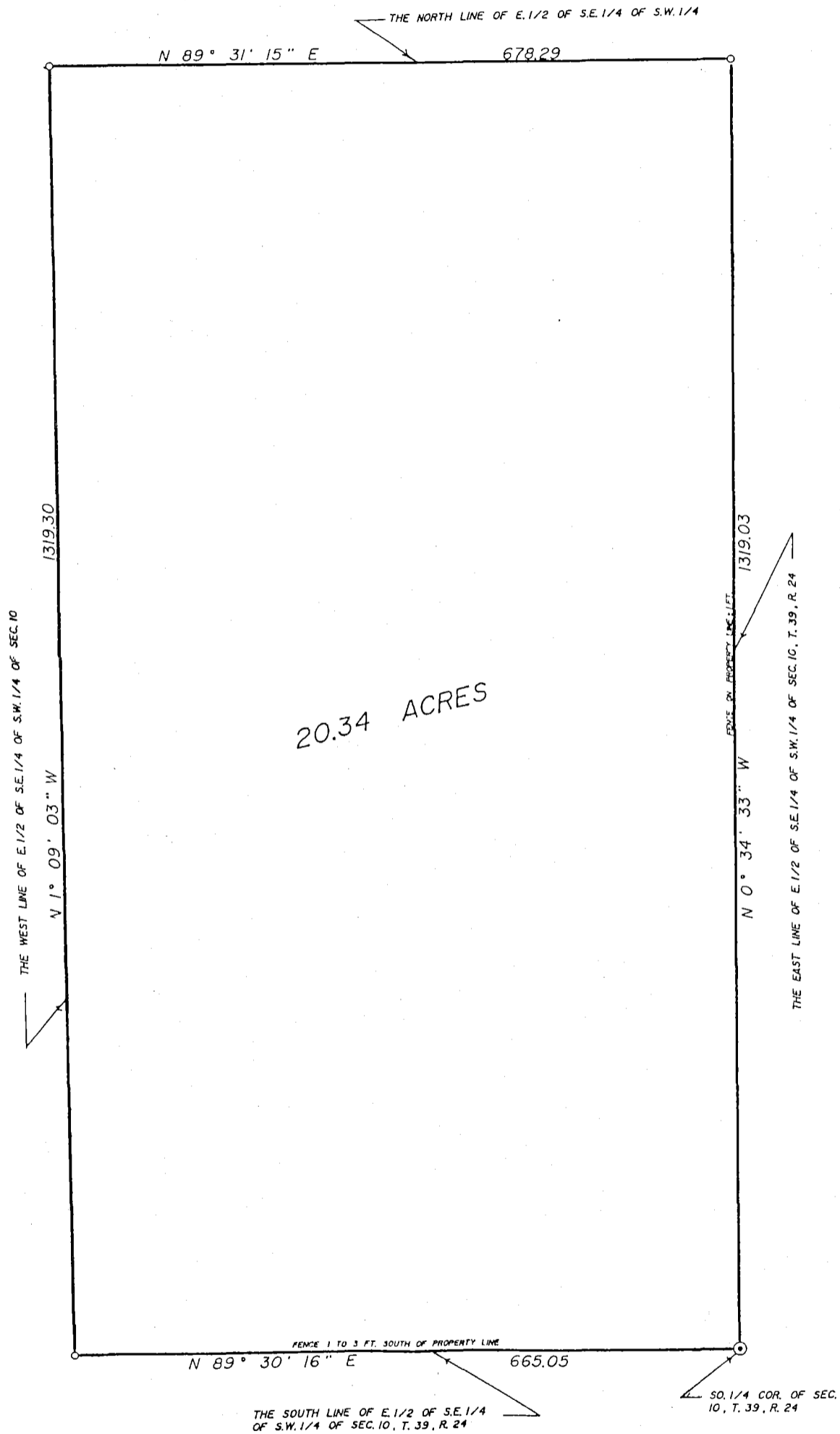
THE CITY OF MORA

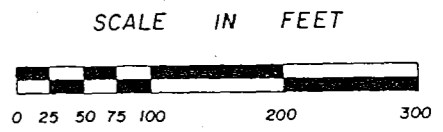
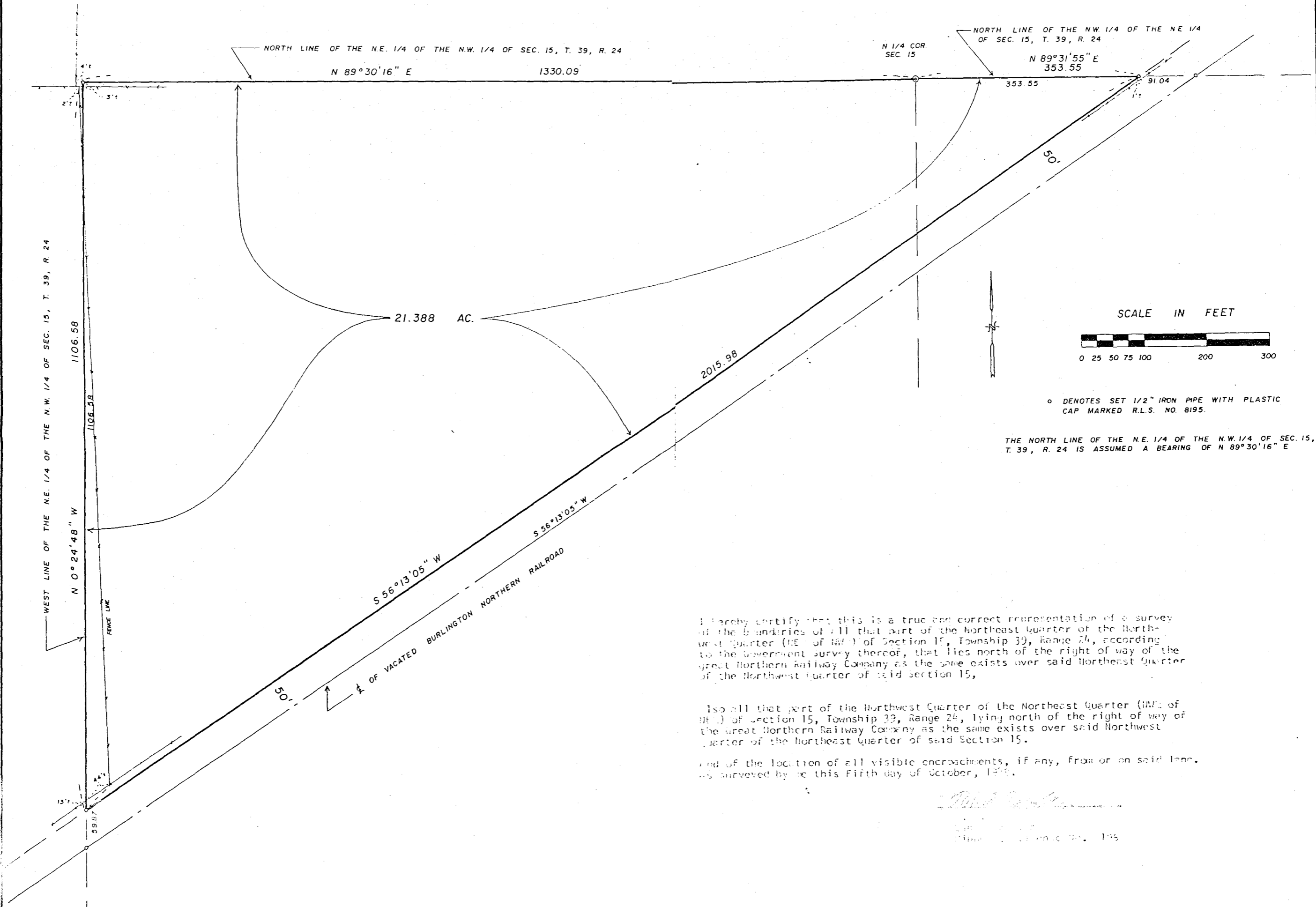
