The Southerly 530 feet of the Westerly 340 feet excepting therefrom the Southerly 40 feet of the SE $\frac{1}{4}$  of SE $\frac{1}{4}$ , Sec. 29, Twp. 110N, Range 32W, containing 3.82 acre, more or less.

2. The territory described above abuts upon the City limits and none of it is presently included within the corporate limits of any incorporated city.
