PETITIONERS STATE: It is hereby requested by all of the property owners of the area proposed for annexation to annex certain property described herein lying in the Township of Marysland to the City of Danvers, County of Swift, Minnesota.

The area proposed for annexation is described as follows:

That part of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Thirteen (13), Township One Hundred Twenty-one North (121N), Range Forty-one West (41W), Swift County, Minnesota, lying South of the centerline of U. S. Highway 12;

and

All that part of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Twenty-four (24), Township One Hundred Twenty-one North (121N), Range Forty-one West (41W), Swift County, Minnesota, lying South of the centerline of U. S. Highway 12, and East of the centerline of Swift County Road No. 17, and North of the right-of-way of Burlington Northern Railroad, and excepting therefrom the East 10 acres of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ -NW $\frac{1}{4}$ ) of said Section 24, Township 121N, Range 41W.

1. There are sixteen (16) property owners in the area proposed for annexation.
2. Sixteen (16) property owners have signed this Petition.
3. Said property is unincorporated, abuts on the city's west boundary, and is not included within any other municipality.
4. The area of land to be annexed is 102.345 acres, which is entirely unplatted.

5. The reason for the requested annexation is based upon the fact that the City of Danvers, Minnesota, is preparing for the installation of a wastewater collection and treatment facility, and that several of the property owners are interested in connecting their properties with said wastewater collection and treatment facility.
6. All of the annexation area is or is about to become urban or suburban in character.
7. The area proposed for annexation is not included in any area that has already been designated for orderly annexation pursuant to M. S. 414.0325.

PETITIONERS REQUEST:

That pursuant to M. S. 414.033, the property described herein be annexed to and included within the City of Danvers, Minnesota.
