The undersigned petitioners hereby represent and show to the City Council of the City of Windom, Cottonwood County, Minnesota:

1. That the petitioners hereby petition the City Council of the City of Windom, Minnesota, to annex to said City the following described premises abutting said City.

All that part of the Southeast Quarter (SE $\frac{1}{4}$) of Section Twenty Two (22) in Township One Hundred Five (105) North of Range Thirty six (36) West of the 5th P. M., described as follows; to-wit:

Commencing at the Northwest corner of said SE $\frac{1}{4}$; thence East along the North line of said SE $\frac{1}{4}$, 531 feet to the center line of that certain public highway known as the River Road; thence continueing East along said North line for a distance of 257.25 feet; thence Southeasterly on a line parallel with the center line of said River Road for a distance of 30 feet; this being the point of beginning of the tract herein described; thence Southwesterly at right angles to said center line 200 feet to a point in said center line; thence Southeasterly along said center line for a distance of 70 feet; thence at right angles to said center line, Northeasterly, for a distance of 200 feet; thence at right Northwesterly 70 feet to the point of beginning. Also, all that part of the SE $\frac{1}{4}$ of said Section 22, descrobed by metes and bounds as follows, to-wit: Beginning at a point in the North boundary line of said SE $\frac{1}{4}$ of said Section 22, 257.25 feet East of the center line of State Aid Road No. 13 (also known as the River Road), thence continuing East along said North boundary line of said SE $\frac{1}{4}$ of said Section 22 a distance of 156.5 feet; thence Southwesterly at right angles to said center line of said State Aid Road No. 13 a distance of 120.5 feet; thence at right angles Northwesterly to the point of beginning.


2. That the petitioners are of the freeholders in the property above described and proposed for annexation.



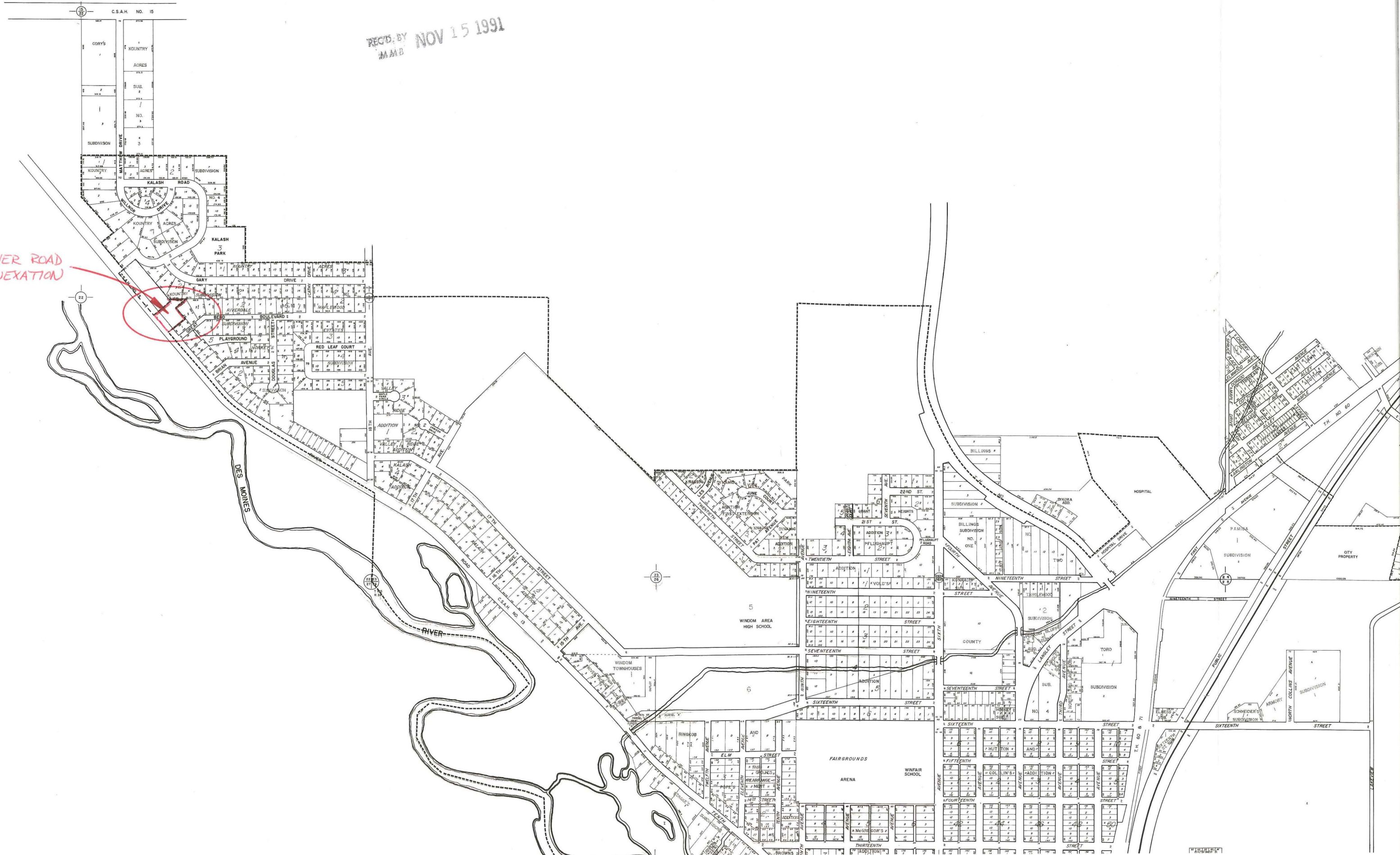

ANNEXATION



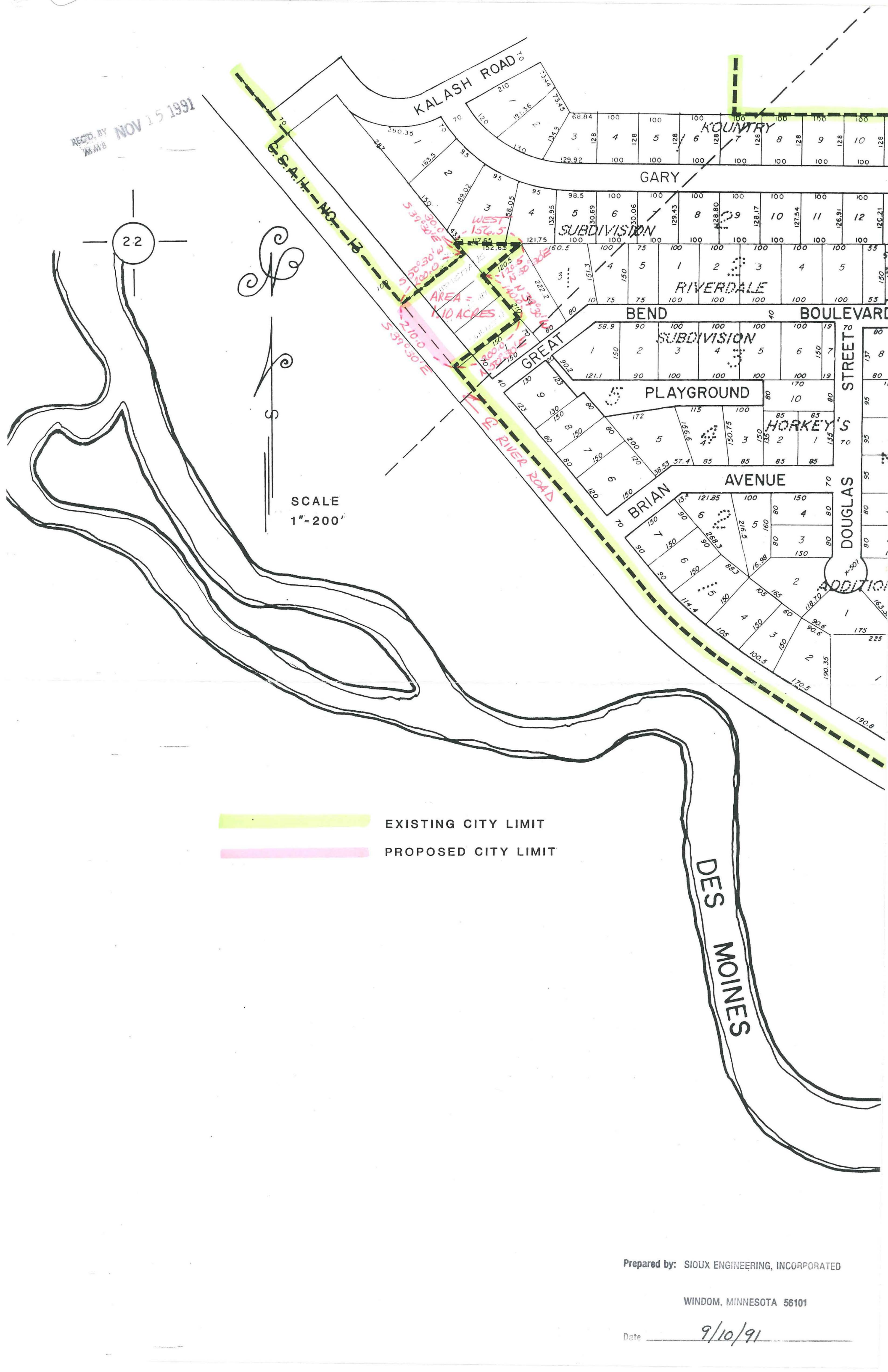
