PETITIONERS STATE:

1. That we, the undersigned, are the majority of the owners of the following described property lying in the Town of LeSauk, County of Stearns, State of Minnesota. The number of petitioners required by statute to commence this proceeding is 7, and the number of petitioners who have signed this petition is 8. Total number of property owners is 12.
2. That said property is unincorporated, abuts upon the limits of the City of Sartell, and is not included within any other municipality.
3. That said property is platted. Legal description of property attached.
4. The acreage of such area is approximately 7.1 acres.
5. The reason for the requested annexation is to have access to city utilities including water and sewer.
