ANNEXATION DESCRIPTION

NORTHERN HEIGHTS EAST PARK

That part of the North Half of the Northwest Quarter of Section 30, and that part of the Southeast Quarter of the Southwest Quarter of Section 19, Township 107 North, Range 13 West, Olmsted County, Minnesota, described as follows:
