

Ordinance 169

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MADISON LAKE TO INCLUDE CERTAIN UNINCORPORATED PLATTED AND UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated April 4, 1992, requesting annexation of the territory hereinafter described was duly presented to the Madison Lake City Council on the 13th day of April, 1992; and

WHEREAS, the petition was signed by all the owners; and

WHEREAS, a waiver of objection to the annexation has been received from the LeRay Town Board dated April 14, 1992; and

WHEREAS, the land described in the petition abuts upon the city limits at the southern boundary thereof;

The City Council of Madison Lake does hereby ordain:

Section 233.01. The City Council hereby determines that the territory described herein abuts upon the city limits and is urban or suburban in character; and that none of the territory is now included within the limits of any city.

Section 233.02 The population of the territory is eight.


Section 233.03. Territory Annexed. The corporate limits of the City of Madison Lake are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:


"Point Pleasant, Part of Lot 54, LeRay Town, 1.600 acres, more accurately described as "That Part of Lot 54, Point Pleasant, that lies within Government Lot 1, Section 3, Town 108, Range 25."

Section 233.04. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk of LeRay, and the Blue Earth County Auditor.


Section 233.05. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 233.04, and approval of the Ordinance by the Minnesota Municipal Board.




