

PETITION FOR ANNEXATION

In the Matter of the Petition of Certain Persons, or for Annexation  
Pursuant to Minnesota Statutes §414.033, subd. 5.

To the Council of the City of Elgin, Minnesota:

We, the undersigned, all the owners of the territory described below, hereby request the Council to annex this territory to the City and to extend the City boundaries to include the same, and for that purpose respectfully state:

(1) The territory to be annexed consists of unplatted land not exceeding 200 acres in area. All of these lands lie entirely within the County of Wabasha, Minnesota, and the description of such lands are as follows:

That part of the Northeast Quarter (NE1/4) of the Northeast Quarter (NE1/4) of Section Twenty-Eight (28), Township One Hundred Eight North (108N), Range Twelve West (12W), Wabasha County, Minnesota, described as follows:

The Southerly 500.00 feet of the Easterly 850.00 feet, including Outlot One (1) in the Northeast one-quarter of the Northeast one-quarter of said Section Twenty-Eight (28); excepting therefrom a parcel recorded as Deed Document No. 188960, described as follows: commencing at the Northeast corner of the Northeast Quarter (NE1/4) of Section Twenty-Eight (28), Township One Hundred Eight (108), Range Twelve (12), Wabasha County, State of Minnesota, thence South along the East line of said Northeast Quarter (NE1/4) of Northeast Quarter (NE1/4), 710.00 feet to the place of beginning; thence West 260.00 feet; thence South 167.55 feet; thence East 260.00 feet to the Easterly line of said Northeast Quarter (NE1/4) of Northeast Quarter (1/4); thence North 167.55 feet to the place of beginning.

Containing 9.40 acres more or less.

(2) The territory described above abuts upon the City limits at the Westerly boundary thereof and none of it is presently included within the corporate limits of any incorporated city.

(3) All of this territory is or is about to become urban or suburban in character.

(4) The population of the area is 0.

(5) That the number of petitioners required by Minnesota Statute §414.033, subd. 5, to commence a proceeding for annexation is 3, the total number of the property owners being 4, and the petitioners and all property owners being as follows: Vernon Kruger, Joan Kruger, Wallace Abbott, Irene Abbott.
