Containing 35.00 acres more or less.

WHEREAS, the Town Board of the Township of Green Lake, having waived any objections for the period of making any objections to the annexation herein, has consented to the annexation of said territory to the City of Spicer;

WHEREAS, the Planning Commission of the City of Spicer has recommended to the Council that the premises be zoned as R-1 Low Density residential.

NOW, THEREFORE, the City Council of the City of Spicer hereby determines, ordains, and declares as follows:

I.

That the annexation would be in best interest of the public, of the City of Spicer, Minnesota and for the best interest of the property affected.

II.

That the property above-described abuts on the city limits and is so conditioned as property to be subject to the city government; and further, is about to become urban in character.

III.

That the property is hereby annexed to and included within, the City of Spicer, Minnesota, as effectually as if it had originally been a part hereof.

IV.

That the premises shall be zoned upon annexation as R-1 Low Density Residential.

v.

That this ordinance shall be filed and shall take effect and be in full force and effect from and after the filing of a copy of this ordinance with the Minnesota Municipal Board, Green Lake Township Clerk, Kandiyohi County Auditor, and the Secretary of the State of Minnesota, from and after its passage and publication.


