

TO THE COUNCIL OF THE CITY OF WINTHROP:

WE THE UNDERSIGNED, THE SOLE OWNERS OF THE TERRITORY DESCRIBED BELOW, HEREBY REQUEST THE CITY COUNCIL TO ANNEX THIS TERRITORY TO THE CITY OF WINTHROP AND TO EXTEND THE CITY BOUNDARIES TO INCLUDE THE SAME AND FOR THAT PURPOSE RESPECTFULLY STATE:

1. THE TERRITORY TO BE ANNEXED CONSISTS ENTIRELY OF LANDS WHICH ARE UNPLATTED AND LESS THAN 200 ACRES. ALL OF THESE LANDS LIE ENTIRELY WITHIN THE COUNTY OF SIBLEY, MINNESOTA, AND THE DESCRIPTION OF SUCH LANDS IS AS FOLLOWS:

BEGINNING AT A POINT 570.8 FEET WEST AND 20 FEET SOUTH OF THE CENTER OF SECTION 6, IN TOWNSHIP 112, NORTH OF RANGE 29 THENCE DUE SOUTH 85 FEET; THEN DUE WEST 142 FEET MORE OR LESS TO THE RIGHT-OF-WAY LINE OF SIBLEY COUNTY STATE AID ROAD NO. 1 AS THE SAME IS NOW LAID OUT AND SITUATED; THENCE NORTH ALONG THE EAST RIGHT-OF-WAY LINE OF SAID SIBLEY COUNTY STATE AID ROAD NO. 1, FOR A DISTANCE OF 85 FEET; THEN EAST 142 FEET MORE OR LESS TO AND TERMINATING AT THE GIVEN POINT OF BEGINNING.

2. THE TERRITORY DESCRIBED ABUTS THE CITY LIMITS AT THE SOUTHEASTERLY BOUNDARY THEREOF AND NONE OF IT IS PRESENTLY INCLUDED WITHIN THE CORPORATE LIMITS OF ANY INCORPORATED CITY.
3. ALL OF THIS TERRITORY IS OR IS ABOUT TO BECOME URBAN OR SUBURBAN IN CHARACTER.
