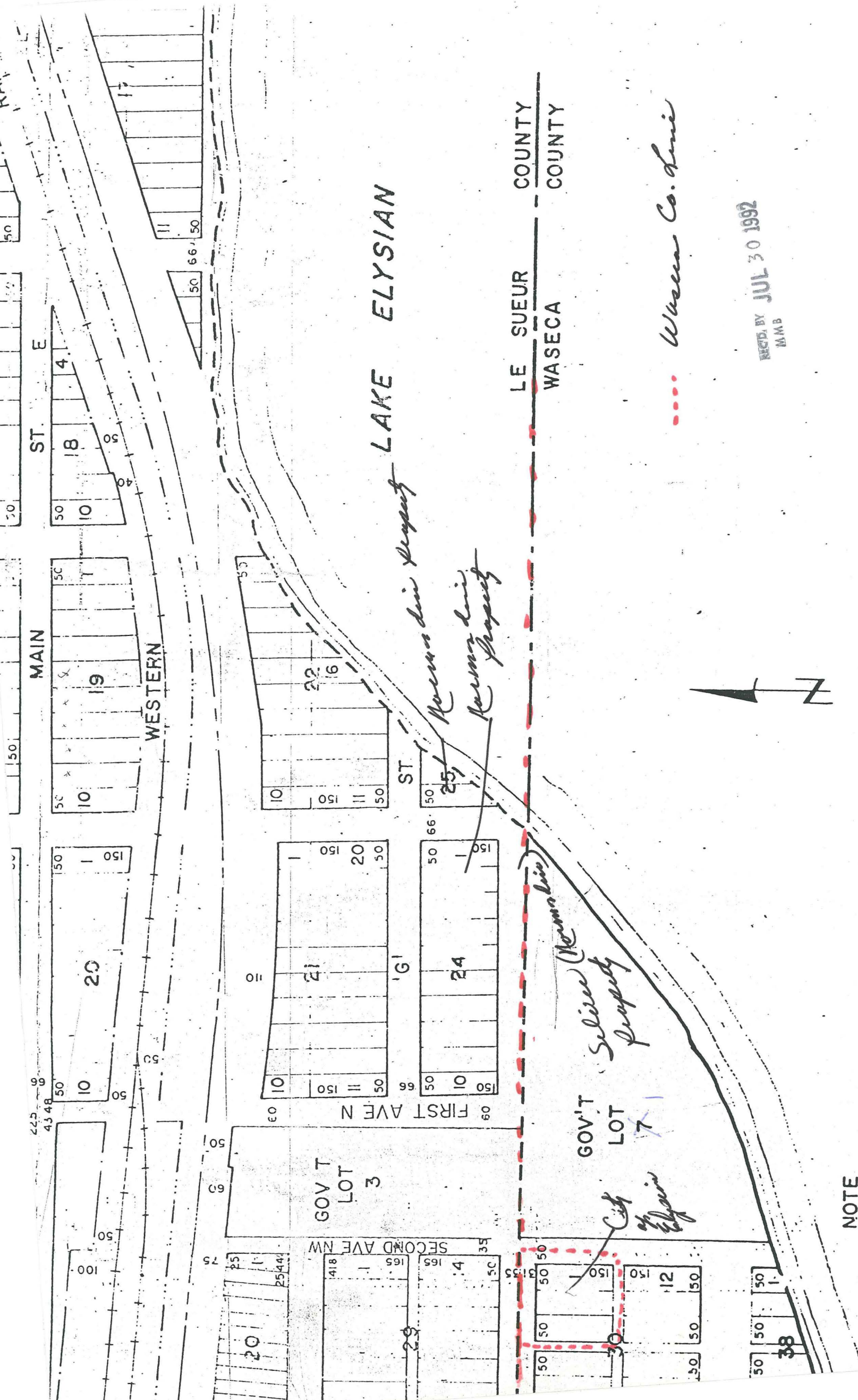

The East part of that fraction in Section Two (2), in the Northeast Quarter of said Section, in Township One Hundred and Eight (108), North of Range Twenty Four (24) West, lying between the County line and Lake Elysian, containing two acres and twenty seven (27) rods more or less, the same being situated in Waseca County, Minnesota.
