ORDINANCE NO. 372

AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED PROPERTY ABUTTING THE CITY OF STAPLES, CONSISTING OF APPROXIMATELY 501 ACRES, MORE OR LESS

WHEREAS, the City of Staples, (the "City") has studied its municipal borders and the City's growth patterns; and

WHEREAS, the City desires to promote orderly growth and provide municipal services in an efficient manner; and

WHEREAS, the City owns or its municipal borders completely surround property abutting the City which property is either located in Thomastown Township in Wadena County or in Staples Township in Todd County which property is more specifically described below; and

WHEREAS, the City desires to proceed with the annexation of said property by ordinance pursuant to Minn. Stat. §414.033; and

WHEREAS, the City Council finds that (i) the property proposed for annexation is, or is about to become, urban or suburban in character, (ii) annexation of said property and municipal government is required to protect the public health, safety, and welfare, and (iii) annexation would be in the best interest of the property proposed for annexation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Staples as follows:

Section 1. Property to be Annexed. The corporate limits of the City are hereby amended to include the property described in paragraphs A and B of this section constituting approximately 50l acres, and said property is hereby annexed to and included within the corporate limits of the City pursuant to Minn. Stat. § 414.033 as if such property had originally been a part of the City.

- A. Property consisting of approximately 153 acres which is owned by the City, presently located in Thomastown Township in Wadena County, and which is more fully described in Attachment A.
- B. Property consisting of approximately 348 acres which is completely surrounded by land currently within the municipal limits of the City, a portion of which is presently located in Thomastown Township in Wadena County and a portion of which is presently located in Staples Township in Todd County, and which is more fully described in Attachment B.
- Section 2. Population of Annexed Property. This property contains a total of 36 households (35 from Thomastown Township and 1 from Staples Township) with an estimated population of 91 (90 from Thomastown Township and 1 from Staples Township).
- Section 3. Zoning Classification of Portions of the Annexed Property. Pursuant to the City Zoning Ordinance, the City Council hereby designates certain portions of the property annexed under Section 1 of this Ordinance as either Agricultural or Commercial. Parcels with the following identification numbers for property tax purposes are Agricultural: R-13.035.3010, R-13.300.0260, R-13.300.0280, R-13.300.0310, R-13.300.0320, (all in Wadena County) and 22-000 1100 (in Todd County). The following parcels in Wadena County are designated as

Commercial: R-13300.0120 and R-13.300.0160.

Section 4. Appropriation of Filing Fee; Authorization to File Ordinance. The amount necessary to pay the filing fee required by the Minnesota Municipal Board for this annexation ordinance is hereby appropriated for such purpose, and the City Administrator is directed to make the necessary filings and provide required information to the Minnesota Municipal Board, the Townships of Thomastown and Staples, the auditors of Wadena and Todd Counties, and the Minnesota Secretary of State.

<u>Section 5. Effective Date.</u> This Ordinance is effective upon publication pursuant to the City Charter and approval by the Minnesota Municipal Board.
