ORDINANCE NO. 70

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF TACONITE TO INCLUDE CERTAIN UNINCORPORATED LAND BUTTING THE CITY OF TACONITE LIMITS

WHEREAS, a Petition dated August <u>10th</u>, 1992, requesting annexation of the territory described herein was duly presented to the City Council on the <u>10th</u> day of <u>August</u>, 1992, and

WHEREAS, the quantity of land embraced within the area described in the Petition is approximately 15.75 more or less acres of platted land, no part of which is included within the limits of any incorporated city, village, or borough, and

WHEREAS, the Petition was signed by all the owners, and whereas, Iron Range Township Board has no objection to the annexation of the land to be annexed and has waived the ninety (90) day period before the annexation ordinance may be adopted, and

WHEREAS, the land described herein abuts the City limits on the easterly boundary thereof.

NOW THEREFORE, the Council of the City of Taconite does ordain:

<u>Section 1</u>: The City Council hereby determines that the annexation will be in the best interest to the City and the territory affected. That the territory described herein abuts the City limits and is urban or suburban in character and that none of said territory is now included within the limits of any city, village or borough.

<u>Section 2</u>: The corporate limits of the City of Taconite are hereby extended to include the platted land described as follows, the same is

Section 3: The City Clerk is hereby directed to file certified Copies of said Ordinance with the Minnesota Municipal Board, the Iron Range Township Clerk, Itasca County Auditor, Itasca County Recorder and the Secretary of State.

<u>Section 4</u>: This Ordinance takes effect upon its passage, publication, filing of certified copies as directed in Section 3.




