An Ordinance Annexing Certain Unplatted Land from Castle Rock Township Pursuant to Minnesota Statutes 414.033(5)

THE CITY COUNCIL OF THE CITY OF FARMINGTON HEREBY ORDAINS AS FOLLOWS:

SECTION I:

The property described below is hereby annexed to the City of Farmington pursuant to Minnesota

Statutes 414.033(5), to wit:

PARCEL #07-00600-013-27The West Half of the Northwest Quarter (W_2^1 of NW_4^1) of Section 6, Township 113 North, Range 19 West, Dakota County, Minnesota EXCEPTING therefrom railroad right of way and ALSO EXCEPTING a tract of land described as follows:

Beginning at the intersection of the East line of the said West Half of the Northwest Quarter (W¹/₂ of NW¹/₄) and the Southeasterly right of way of the Milwaukee Railroad, said point lying 1,392.40 feet South of the Northeast corner of the said West Half of the Northwest Quarter (W¹/₂ of NW¹/₄); thence South along said East line a distance of 320.0 feet; thence deflecting to the right at an angle of 104° 44' 30" a distance of 393.50 feet to a point on the Southeasterly right of way; thence Northeasterly along said right of way a distance of 440.0 feet, more or less, to the point of beginning. SECTION III: This annexation shall be effective at such time as this ordinance has been approved by the Minnesota Municipal Board and the ordinance has been published in the official newspaper.




