

ORDINANCE 217

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LE ROY TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, A CERTAIN PETITION REQUESTING ANNEXATION WAS DULY PRESENTED TO THE COUNCIL ON THE 29TH DAY OF JULY, 1992, AND

WHEREAS THE PETITION WAS SIGNED BY ALL OWNERS, AND

WHEREAS, NO OBJECTIONS TO THE ANNEXATION HAVE BEEN RECEIVED FROM THE TOWN BOARD, OR THE GOVERNMENT BODY OF ANY MUNICIPALITY WHOSE BOUNDARIES ABUT UPON THE BOUNDARIES OF THE LAND TO BE ANNEXED; AND

WHEREAS, THE LAND DESCRIBED IN THE PETITION ABUTS UPON THE CITY LIMITS AT THE EAST BOUNDARY THEREOF;

THE COUNCIL OF THE CITY OF LE ROY, MINNESOTA ORDAINS:

SECTION 1. THE CITY COUNCIL HEREBY DETERMINES (1) THAT THE TERRITORY DESCRIBED HEREIN ABUTS UPON THE CITY LIMITS AND IS URBAN OR SUBURBAN IN CHARACTER; AND (2) THAT NONE OF THE TERRITORY IS NOW INCLUDED WITHIN THE LIMITS OF ANY CITY.

SECTION 2. THE POPULATION OF THE TERRITORY IS 0.

SECTION 3. THE CORPORATE LIMITS OF THE CITY ARE HEREBY EXTENDED TO INCLUDE THE PLATTED LAND DESCRIBED AS FOLLOWS AND THE SAME IS HEREBY ANNEXED TO AND INCLUDED WITHIN THE CITY AS EFFECTUALLY AS IF IT HAD ORIGINALLY BEEN PART THEREOF:

3.3 ACRES OF OUTLOT 12 OF W.W. SWEETS ADDITION TO LE ROY TOWNSHIP, AND FURTHER DESCRIBED AS FOLLOWS:
COMMENCING AT A POINT 854 FEET EAST AND 75.0 FT. SOUTH OF THE NORTHWEST CORNER OF THE SOUTHEAST QUARTER (SE 1/4) OF SECTION 34, TOWNSHIP 101 NORTH, RANGE 14 WEST, THENCE EAST PARALLEL WITH THE EAST AND WEST QUARTERLINE 726 FEET, THENCE SOUTH 240 FEET, THENCE WEST 726 FEET, THENCE NORTH 240 FEET TO THE PLACE OF BEGINNING, ALL IN SECTION 34, TOWNSHIP 101 NORTH, RANGE 14 WEST.

SECTION 5. THIS ORDINANCE TAKES EFFECT UPON ITS PASSAGE AND PUBLICATION AND THE FILING OF THE CERTIFIED COPIES AS DIRECTED IN SECTION 3, AND APPROVAL OF THE ORDINANCE BY THE MINNESOTA MUNICIPAL BOARD.


