ORDINANCE NO. 14, 2nd Series

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLEEPY EYE TO INCLUDE CERTAIN UNPLATTED LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a Petition dated October 20, 1992, was presented to the City Council of the City of Sleepy Eye requesting annexation of territory for unplatted land located in Home Township, and

WHEREAS, the territory described abuts upon the City limits and it is determined by the Council that the property is, or is about to become, urban or suburban in character.

The City of Sleepy Eye does therefor ordain as follows:

SECTION 1. That the annexation will be to the best interests the City and of the territory affected, that the territory described herein abuts upon the City limits and is or is about to become urban or suburban in character, and that none territory is now included in the limits of any City and does not abut upon the limits of any other city.

SECTION 2. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

THAT PART OF THE WEST HALF OF THE SOUTHEAST QUARTER OF SECTION 29, TOWNSHIP 110 NORTH, RANGE 32 WEST, BROWN COUNTY, MINNESOTA, described as follows:

Beginning at the Southwest corner of Outlot A of Kroschel's Subdivision in the Northwest Quarter of said Southeast Quarter of Sec. 29; then South 89 degrees 58 minutes 48 seconds East, an assumed bearing, along the south line of said Outlot A and the easterly prolongation of said south line 470.00 feet; then South 00 degrees 08 minutes 36 seconds East parallel with the west line of said Southeast Quarter 1385.43 feet to the northerly right-of-way line of the Dakota Minnesota and Eastern Railroad; then South 78 degrees 03 minutes 46 seconds West 480.13 feet to the said west line of the Southeast Quarter of Sec. 29; then North 00 degrees 08 minutes 36 seconds West along said west line 1484.90 feet to the point of beginning containing 15.5 acres, more or less and being subject to easements of record in said county and state.


