### IN THE MATTER OF THE PETITION OF CERTAIN PERSONS FOR ANNEXATION TO THE CITY OF WINDOM, COTTONWOOD COUNTY, MINNESOTA PURSUANT TO MINNESOTA STATUTES 414.033, SECTION 5

TO: Council of the City of Windom, Minnesota

and

Minnesota Municipal Board 165 Metro Square Building St. Paul, Minnesota, 55101

The undersigned petitioners hereby represent and show to the City Council of the City of Windom, Cottonwood County, Minnesota:

1. That the petitioners hereby petition the City Council of the City of Windom, Minnesota, to annex to said City the following described premises abutting said City.

> Lots in Tibodeau's Center located in the Southeast Quarter (SE<sup>1</sup>/<sub>4</sub>) of Section 24, Township 105, Range 36, described as follows:

- (1) The Southwest 60 foot frontage on Arlington Avenue in Block 2 of Tibodeau's Center.
- (2) All of Block 2, except the Southwest 185 feet of Block 2 of Tibodeau's Center.
- (3) Lot 1 in Block 4 of Tibodeau's Center.
- (4) Lots 6, 7, 8, 9, 10, 11, 12, 13, 14, and 15 in Block 4 of Tibodeau's Center.
- (5) Lots 16, 17, 18 and 19 in Block 4 of Tibodeau's Center.
- (6) All of Block 5 of Tibodeau's Center.
- (7) Lot 1 in Block 6 of Tibodeau's Center.
- (8) Lots 5 and 6 in Block 6 of Tibodeau's Center.
- (9) Lots 1, 2, 3, 4, 5, 6, 7, 8 and 9 except the East 10 feet, in Block 7 of Tibodeau's Center.

The easterly 135 feet of the Westerly 195 feet of Block Two (2); and

Lot Two (2), Three (3), Four (4), Seven (7), Eight (8) and Nine (9) in Block Six (6),

All in Tibodeau Center Township 105 North, Range 36 West of the 5th P.M.

Lot 10 in Block 7 in Tibodeau's Center of the Southeast Quarter of Section 24, Township 105 North, Range 36 West of the Fifth P.M. and a tract described as follows: Beginning at the most Southeasterly corner of Lot 9 in Block 7 in Tibodeau's Center of the Southeast Quarter of Section 24, Township 105 North, Range 36 West of the Fifth P.M. thence in a Southwesterly direction along the Southerly boundary line of said Lot 9 a distance of 10 feet; thence at right angles in a Northerly direction parallel with the Easterly boundary of said Lot 9 a distance of 106 feet to the Northerly boundary of said Lot 9; thence at right angles in an Easterly direction along the Northerly boundary of said Lot 9; thence at right angles in a Southerly direction along the Mortherly boundary of said Lot 9; thence at right angles in a Southerly direction along the Basterly boundary of said Lot 9; thence at right angles in a Southerly direction along the Easterly boundary of said Lot 9; thence at right angles in a Southerly direction along the Easterly boundary of said Lot 9; thence at right angles in a Southerly direction along the Easterly boundary of said Lot 9; thence at right angles in a Southerly direction along the Easterly boundary of said Lot 9 a distance of 106 feet to the point of beginning.

That part of the Northwest Quarter of the Southeast Quarter of the Section 24, Township 105 North, Range 36 West, shown as Parcel 207S on Minnesota Department of Transportation Right of Way Plat Numbered 17-8 as the same is on file and of record in the office of the County Recorder in and for Cottonwood County, Minnesota; containing 0.02 acre, more or less.

AND

Lot Three (3), Block Three (3), Tibodeau's Center, Section twenty-four (24), Township One Hundred Five (105), Range Thirty-six (36), Cottonwood County, Minnesota. AND

All of the following described premises located in Tibodeau's Center of the Southeast Quarter (SE¼), Section Twenty-four (24), Township One Hundred Five (105), Range Thirty-six (36), Cottonwood County, Minnesota, described as follows, to-wit: All of Block 1, Lots 1 and 2, Block 3; and all that portion of Arlington Avenue vacated by order of the District Court of Cottonwood County, Minnesota, and recorded in Book 85 of Deeds on Page 334, described as follows, to-wit: That portion of the following described street known and designated as Arlington Avenue in Tibodeau's Center of the SE 1/4, Section 24, Township 105, Range 36, Cottonwood County, Minnesota, lying and being Westerly and Southerly of a line extending from the most Southerly corner of Lot 3, Block 3, Tibodeau's Center, thence Southeasterly at right angles with the most Southerly boundary line of said Lot 3 to a point where said line intersects with the most Northerly point of said Block 1, said line being an extension of the boundary line which divides Lots 2 and 3 in said Block 3; EXCEPT that part of said Block 1 and that part of said vacated Arlington Avenue shown as parcel 207E on Minnesota Department of Transportation Right of Way Plat numbered 17-8 as the same is on file and of record in the office of the County Recorder in and the Cottonwood County, Minnesota.

- 2. That the petitioners are of the freeholders in the property above described and proposed for annexation.
- 3. That the area proposed for annexation is not presently served by public sewer and water.
- 4. That said area is urban in character and is so conditioned as to be property subject to municipal government.
