AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GRAND RAPIDS TO INCLUDE CERTAIN LAND OWNED BY THE ESTATE OF SELMA A. MOOD AND ABUTTING THE CITY OF GRAND RAPIDS DESCRIBED AS THE NE1/4 OF THE NW1/4, SECTION 33-55-25

WHEREAS, Alfred Mood, Executor of the Estate of Selma A. Mood has filed a petition for annexation dated December 11, 1992, requesting that certain land, as legally described below:

NE¼ of the NW¼ of Section 33, Township 55N, Range 25W of the Fourth Principal Meridian, Itasca County Minnesota.

be annexed to the City of Grand Rapids, and

WHEREAS, Alfred Mood represents that the estate is the sole owner of the property, that the property is unincorporated, abuts the limits of the City of Grand Rapids, is not included within any other municipality, is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes §414.0325, and is approximately two acres in size.

NOW THEREFORE, The City Council of Grand Rapids, Minnesota does hereby ordain:

Section 1. The City Council hereby determines and finds that the property abuts the municipality, that the area to be annexed is sixty (60) acres or less, that the property is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes §414.0325, that the municipality has received a properly prepared Petition for Annexation from all of the owners of the property, and that the Petition Complies with all of the provisions of Minnesota Statute §414.033.

- Section 2. The property is urban in nature or about to become so.
- <u>Section 3</u>. The corporate limits of the City of Grand Rapids are hereby extended to include the Property and the same is hereby annexed to and included within the City of Grand Rapids as if the property had originally been part thereof.
- <u>Section 4</u>. The City clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Grand Rapids Township, the Itasca County Auditor, and the Minnesota Secretary of State.
- Section 5. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4 and approval of the Ordinance by the Minnesota Municipal Board.
