

ORDINANCE #425

**AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF PRINCETON TO INCLUDE CERTAIN LAND OWNED BY
HENRY MEYER AND STEVE MEYER
AND ABUTTING THE CITY OF PRINCETON**

WHEREAS, Henry Meyer and Steve Meyer have filed a petition dated March 4, 1993, requesting that certain land, as legally described below:

The East 624 feet of the North 416 feet of the Southwest Quarter of the Southwest Quarter (SW 1/4 of SW 1/4) of Section Twenty-one (21), Township Thirty-six (36), Range Twenty-six (26), Mille Lacs County, Minnesota,

be annexed to the City of Princeton; and

WHEREAS, Henry Meyer and Steve Meyer represent that they are the sole owners of the property, that the property is unincorporated, abuts the limits of the City of Princeton, is not included within any other municipality, is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, and is approximately six (6) acres in size.

NOW, THEREFORE, the City Council of Princeton, Minnesota, does hereby ordain:

Section 1. The City Council hereby determines and finds that the property abuts the municipality, that the area to be annexed is sixty (60) acres or less, that the property is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, that the municipality has received a properly prepared Petition for Annexation from all of the owners of the property, and that the Petition complies with all of the provisions of Minnesota Statute 414.033.

Section 2. The property is urban in nature or about to become so.

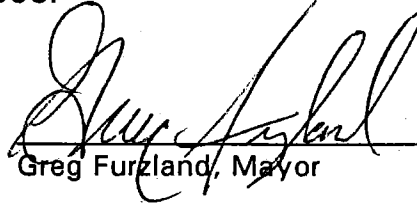
Section 3. The corporate limits of the City of Princeton are hereby extended to include the Property and the same is hereby annexed to and included within the City of Princeton as if the property had originally been part thereof.

Section 4. The Deputy City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Princeton Township, the Mille Lacs County Auditor, and the Minnesota Secretary of State.

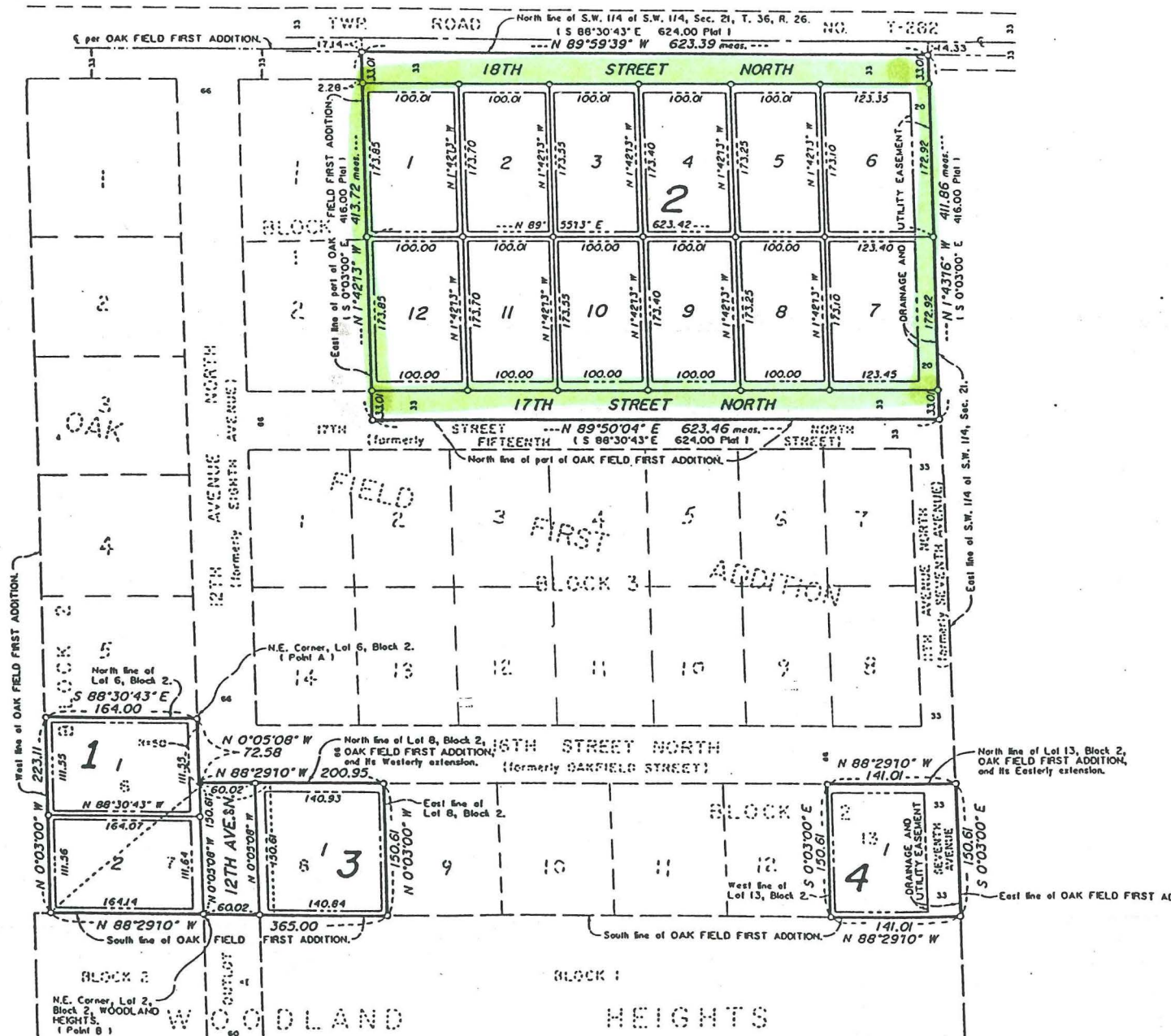

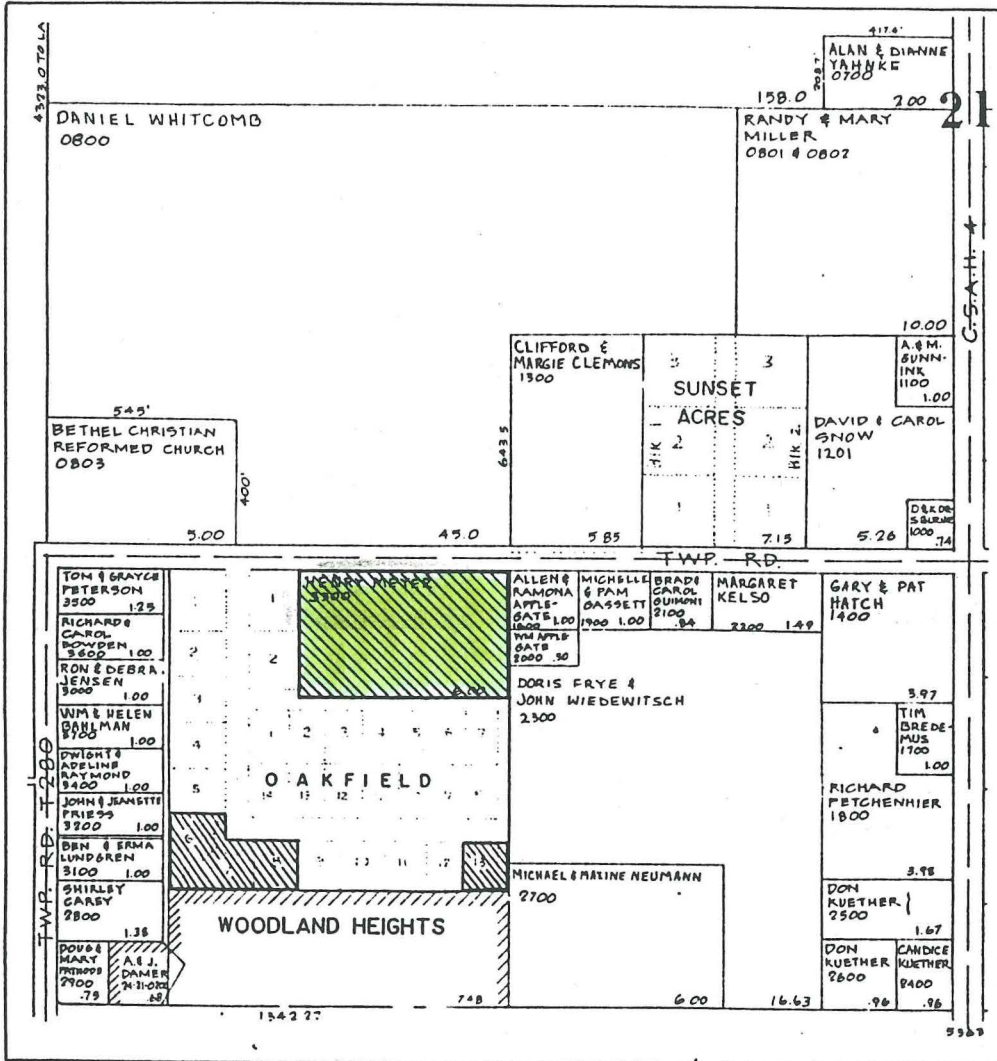
