

ORDINANCE NO. 194

ORDINANCE REPEALING ORDINANCE NO. 190 AND ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HAWLEY TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING SIXTY ACRES IN AREA ABUTTING UPON THE CITY LIMITS IN ACCORDANCE WITH MINN. STAT. §414.033, SUBD. 2(3).

WHEREAS, a certain Petition signed by Jeffrey W. Hukriede and Mischelle R. Hukriede, Paul DesChene and Rebecca DesChene; and Anthony Kronbeck and Audrey Kronbeck, requesting annexation of the land hereinafter described was duly presented to the City Council of the City of Hawley on December 6, 1993; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is less than 60 acres of unplatted land no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the Petition was signed by all of the owners of the real estate involved, thereby complying with the provisions of Minn. Stat. §414.033, Subd. 2(3); and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the existing City limits at the northerly boundary of said City as indicated on the attached map marked as Exhibit A;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Hawley, pursuant to the authority granted by Minn. Stat. §414.033, Subd. 2(3), as follows:

Section 1. The City Council does hereby determine (1) that the annexation will be to the best interest of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.


Section 2. TERRITORY ANNEXED. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to an included within the City as effectually as if it had originally been a part thereof, said land being described as follows:

Beginning at the quarter stake on the East line of Section 2, Township 139, Range 45 West of the 5th Principal Meridian, said quarter stake being at the Southeast corner of the Northeast Quarter (NE1/4) of said Section 2, thence running North 25 7/17 rods, thence running West 17 rods, thence South 25 7/17 rods, thence East 17 rods to the point of beginning, Clay County, Minnesota, containing 2.7 acres, more or less.


Section 3. FILING. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, 475 McColl Building, 366 Jackson St., St. Paul, MN 55101-1925; the Secretary of State; Hawley Township; the County Auditor and the County Recorder.

Section 4. EFFECTIVE DATE. This Ordinance takes effect upon its passage.


