PETITION

Petitioners, Erwin DeBolt and Irene F. DeBolt, husband and wife, state as follows to the honorable members of the City Council, Pine River, Minnesota:

1. That the Petitioners are the owners of a certain tract of land which is directly adjacent to the City of Pine River, and which is now urban in character.

2. That the Petitioners, as sole owners of that tract of land, do hereby describe it as follows:

The East Half of the West Half of Lot 4, Block 1, Plat of Dutch Town, according to the plat thereof on file and of record in the office of the County Recorder of Cass County

3. That said property is unincorporated and abuts upon the present limits of the City of Pine River, Minnesota. That property is not included within any other municipality. Said property is platted and is approximately acres in area.

4. That the Township of Barclay has waived its right to object to this Petition, by Resolution of its Township Board dated MARCH 9, 1993, a copy of which is attached as Exhibit A.

5. That a copy of this Petition is being served for informational purposes upon Barclay Township, the Board of Supervisors of Cass County, Minnesota, and upon the Minnesota Municipal Board.




