# ordinance no. 288/

AN ORDINANCE ANNEXING TO THE CITY OF ROCHESTER A PORTION OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 8, PORTIONS OF SECTIONS 17, 21, 33 AND 34, AND PORTIONS OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 20, TOWNSHIP 107 NORTH, RANGE 14 WEST, OLMSTED COUNTY, MINNESOTA.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

Section 1. The Common Council of the City of Rochester has initiated the annexation of the lands described in Exhibit B, attached hereto and incorporated herein, located in Cascade Township, Olmsted County, Minnesota.

Section 2. The quantity of land included in this annexation is approximately 621.6 acres in size.

Section 3. The Common Council of the City of Rochester does hereby determine that the land described in Exhibit B is subject to annexation by the City of Rochester pursuant to a Joint Resolution For Orderly Annexation, as amended by the parties on July 7, 1993, executed by the City of Rochester and the Town of Cascade.

Section 4. Therefore, pursuant to the Joint Resolution For Orderly Annexation, as amended, the land described in Exhibit B is hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal board, the Cascade Town Clerk, the County Auditor, and the Secretary of State.
