

Councilmember Huntley introduced the following ordinance and moved for its adoption:

ORDINANCE NO. 93-08-14

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE  
CITY OF GRAND RAPIDS TO INCLUDE CERTAIN LAND OWNED BY  
BLANDIN PAPER COMPANY AND ABUTTING THE CITY OF GRAND RAPIDS

WHEREAS, the City of Grand Rapids received a petition from Blandin Paper Company requesting the annexation of the following described property:

"That part of Government Lot 2, Section 9, Township 55N, Range 25W, Itasca County, Minnesota lying Easterly of the centerline of State Highway Number 38, and lying notherly of the following described line: Beginning at the Northeast corner of Lot 3, Block 1, Riendeau Addition to Grand Rapids, according to the recorded plat thereof in said county and assuming the North line of said Block one bears West; thence North 69 degrees 13 minutes 17 seconds West 385.22 feet to the centerline of said State Highway Number 38 and said line there terminating."

WHEREAS, Blandin Paper Company is the sole owner of the property, the property is unincorporated, abuts the limits of the City of Grand Rapids, is not included within any other municipality, is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes §414.0325, and is approximately 37 acres in size.

NOW THEREFORE, The City Council of Grand Rapids, Minnesota does hereby ordain:

Section 1. The City Council hereby determines and finds that the property abuts the municipality, that the area to be annexed is sixty (60) acres or less, that the property is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes §414.0325, that all of the owners of the property have petitioned its annexation, and that the all of the provisions of Minnesota Statute §414.033 have been complied with.

Section 2. The property is urban in nature or about to become so.


Section 3. The corporate limits of the City of Grand Rapids are hereby extended to include the Property and the same is hereby annexed to and included within the City of Grand Rapids as if the property had originally been part thereof.

Section 4. The City clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Grand Rapids Township, the Itasca County Auditor, and the Minnesota Secretary of State.



ITASCA COUNTY, MINNESOTA.

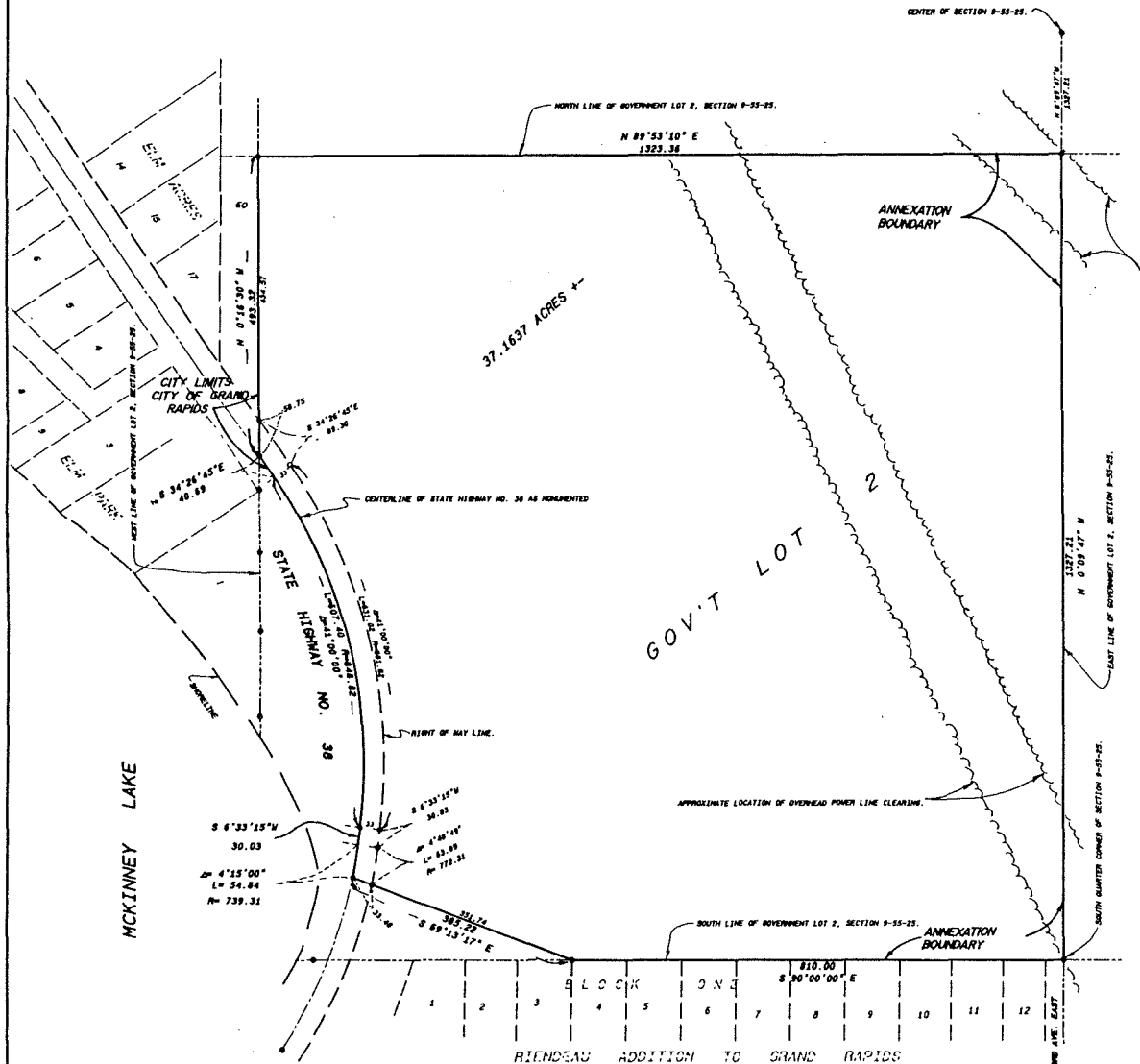
