ORDINANCE NO. 310

AN ORDINANCE AMENDING ORDINANCE NO 309 OF THE CITY OF CHATFIELD BEING AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF CHATFIELD, MINNESOTA

The Council of the City of Chatfield, Minnesota does ordain:

Section 1. The land described in Exhibit A attached to Ordinance No. 309 is hereby annexed to the City of Chatfield, Minnesota, pursuant to Minnesota Statute 414.033 Subd. 2. A Petition for Annexation by the landowners has been received.

Section 2. The lands described in Exhibits B and C attached to Ordinance No. 309 are hereby annexed to the City of Chatfield, Minnesota, pursuant to Minnesota Statute 414.033 Subd. 2. Parts of said property may have been previously annexed but the entire parcels are now being annexed to clarify annexation. A Petition for Annexation by the landowners of the property described on Exhibit B has been received. The property set forth on Exhibit C is approximately 5 acres and appears to be completely surrounded by property already annexed to the City.

Section 3. That this Council recommends to the Minnesota Municipal Board that annexation of the aforesaid lands be approved and granted.

Section 4. That upon approval of this Ordinance and Amended Ordinance 309 by the Minnesota Municipal Board, all parts inconsistent with this Ordinance shall be altered and modified to the extent of such inconsistency, but no further.
