

PETITION FOR ANNEXATION

In the matter of the Petition of Eugene H. Fichter, a single person, for annexation pursuant to Minnesota Statutes, Section 414.033, Subdivision 5.

TO THE CITY COUNCIL OF THE CITY OF ROSEAU, MINNESOTA:

The undersigned, being the sole owner of the territory described below, hereby requests the council to annex this territory to the city and to extend the city boundaries to include the same, and for that purpose respectfully state:

1. The territory to be annexed consists entirely of unplatted lands, said land not exceeding 200 acres in area; the description of said lands is as follows:

The South Seven Hundred Thirty-five (735) feet of the East Four Hundred Sixty-two (462) feet of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Fourteen (14), in Township One Hundred Sixty-two (162) North, Range Forty (40) West of the 5th P.M. in Minnesota, EXCEPTING THEREFROM the South Six Hundred Sixty (660) feet of the East Two Hundred Twenty-two (222) feet of said SE $\frac{1}{4}$ SW $\frac{1}{4}$.

2. The territory described above abuts upon the city limits of the City of Roseau at the westerly and northerly boundaries and none of said territory is presently included within the corporate limits of any incorporated city.

3. The territory described above does not abut upon the boundaries of any other township.

4. The territory described above contains 3.64 acres more or less.

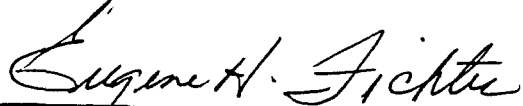
5. The territory described above is primarily commercial in nature.

Range 40 W.

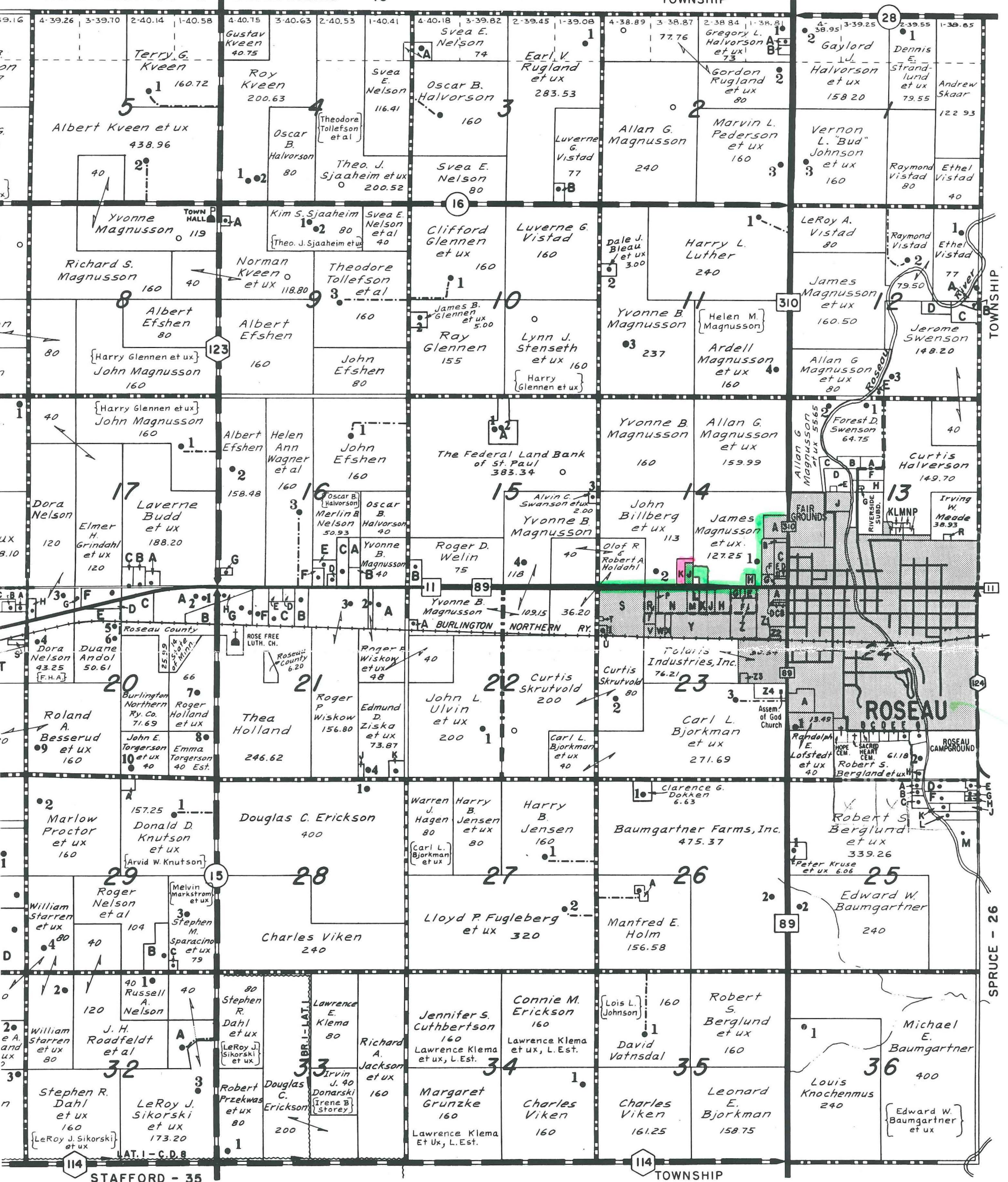

TOWNSHIP

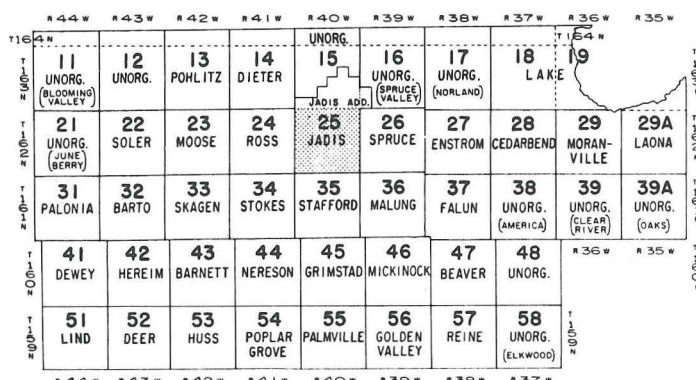
