THE CITY COUNCIL OF BIG FALLS ORDAINS:


1. That the following described real property is hereby annexed to the City of Big Falls and the corporate limits of the City are extended to include such property. The description of said property is as follows:


Riverside Addition to Big Falls: Block 1-lots- 1 through 16.

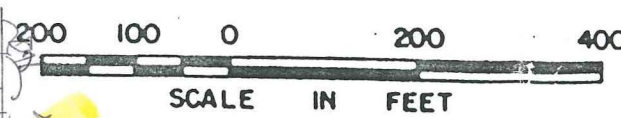
