## ORDINANCE NO. 1047

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WILLMAR, A MUNICIPAL CORPORATION OF THE STATE OF MINNESOTA, TO INCLUDE CERTAIN LANDS OWNED BY THE CITY

WHEREAS, the City of Willmar acquired certain property for the purpose of airport development; and

WHEREAS, said property is owned in fee by the City of Willmar; and

- WHEREAS, it is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County, Minnesota; and
- WHEREAS, pursuant to Minnesota law, said land may be annexed by ordinance; and
- WHEREAS, the said real estate to be annexed is described as follows, to-wit:

The Southwest 1/4 of the Southeast 1/4, and part of the Northwest 1/4 of the Southeast 1/4 described as the South 215 feet of the West 565 feet, Section 17, Township 119, Range 35.

## and

The North 1320 feet of the West 1980 feet of the Northwest 1/4 of Section 20, Township 119, Range 35.

NOW, THEREFORE, the City Council of the City of Willmar hereby determines, ordains, and declares as follows:

Section 1. <u>STATUTORY COMPLIANCE</u>. The City Council hereby determines and finds that the property abuts the municipality, and that the annexation complies with all of the provisions of Minnesota Statute 414.033.

Section 2. <u>BEST INTEREST OF THE CITY OF WILLMAR AND AREA TO</u> <u>BE ANNEXED</u>. That the annexation will be in the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 3. <u>OWNED BY THE CITY</u>. That the real estate above described is owned in fee title by the City of Willmar.

Section 4. <u>ANNEXATION</u>. That the said real estate is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof. Section 5. <u>ZONING</u>. That the above described real estate shall be zoned A-Agriculture.

Section 6. <u>ACREAGE</u>. The parcels have a combined area of 102.79 acres.

Section 7. <u>EFFECTIVE DATE</u>. This Ordinance shall be filed and shall take effect and be in full force and effect from and after filing a certificate thereof with the Minnesota Municipal Board, the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its adoption and publication.
