AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WARROAD, MINNESOTA, TO INCLUDE LAND NOT EXCEEDING SIXTY (60) ACRES IN AREA AND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated <u>May 17</u>, 1994, requesting annexation of the territory hereinafter described was duly presented to the City Council of the City of Warroad, Minnesota, on the 23rd day of <u>May</u>, 1994; and

WHEREAS, the Petition was signed by the sole owner; and
