# ORDINANCE NO. 1.7016

### AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MADELIA TO INCLUDE CERTAIN UNINCORPORATED UNPLATED LAND ABUITING UPON THE CITY LIMITS

WHEREAS, a certain petition dated June 2, 1994, requesting annexation of the territory hereinafter described is duly presented to the Council.

AND WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 0.93 acres of unplatted land; no part of which is included within the limits of an incorporated city or borough;

AND WHEREAS, the petition was signed by all owners of said land;

AND WHEREAS, said land is urban in character or about to become so;

AND WHEREAS, the land described in the petition abuts upon the City on three sides.

NOW THEREFORE, the City Council of the City of Madelia, Minnesota, does hereby ordain as follows:

### Section 1.

A. The City Council hereby determines that the annexation will be to the best interests of the City and to the territory affected.

B. The territory described herein abuts upon the city limits and is urban or suburban in character or is about to become so.

C. That none of said territory is now included within the limits of any city or borough.

# Section 2.

The corporate limits of the City of Madelia are hereby extended to include the unplatted land described as follows and the same is hereby annexed to include the same within the City as effectively as if it had originally been a part hereof:

See Exhibit A attached hereto and made a part hereof.

#### Section 3.

The City Clerk is hereby directed to file a certified copy of this Ordinance with the Minnesota Municipal Board, the Minnesota Secretary of State, the Watonwan County Auditor, and the Clerk of the Madelia Township Board.

Section 4.

This Ordinance takes effect upon its passage and publication and filing of certified copies as directed in Section 3. and is final on the date the ordinance is approved by the Minnesota Municipal Board.
