The undersigned petitioners are the owners and do hereby request and desire that certain lands be annexed to the City of Brownton, McLeod County, Minnesota, and to be included within the corporate limits of the City of Brownton, said lands being described as follows, to-wit:

II.

The said lands described in the preceding paragraph about the present corporate limits of the City of Brownton. The lands are unplatted and are less than ten (10) acres in size. The lands are not now included in any other municipality.

III.

No Petition for Annexation of any part of said lands is presently before the Commission.

IV.

The petitioners constitute the only landowners having any interest in said lands.

V.

The undersigned petitioners believe that said lands are now or about to become urban or suburban in character and the annexation of said lands to the City of Brownton would be in the best interest of the City of Brownton.

VI.

That this Petition is brought pursuant to Minnesota Statutes, Section 414.033, subd. 5.

WHEREFORE, Petitioners pray the following:

1. That said annexation be approved by the authorities prescribed by law and that the City of Brownton annex said premises by ordinance as provided by law.




PROPOSED LEGAL DESCRIPTION (For Annexation Purposes)
(Jerome Streich Property)

That part of the Southeast Quarter of the Northwest Quarter (SE 1/4, NW 1/4), Section 32, Township 115 North, Range 29 West, McLeod County, Minnesota described as follows:

Beginning at the northeast corner of STREICH'S ADDITION according to the plat on file in the office of the County Recorder, McLeod County, Minnesota; thence South 89 degrees 53 minutes 11 seconds East, assumed bearing along the north line of said SE 1/4, NW 1/4, a distance of 493.66 feet to the northeast corner of said SE 1/4, NW 1/4; thence South 00 degrees 06 minutes 49 seconds West 566.00 feet along the east line of said SE 1/4, NW 1/4; thence North 89 degrees 53 minutes 11 seconds West 700.88 feet; thence North 85 degrees 15 minutes 09 seconds West 123.78 feet; thence North 00 degrees 14 minutes 14 seconds East 256.00 feet to the southwest corner of said STREICH'S ADDITION; thence South 89 degrees 53 minutes 11 seconds East 329.40 feet along the south line of said STREICH'S ADDITION to the southeast corner of said STREICH'S ADDITION; thence North 00 degrees 14 minutes 14 seconds East 300.00 feet along the east line of said STREICH'S ADDITION to the point of beginning containing 8.42 acres.
