That I am the County Auditor of McLeod County, Minnesota. That on the 14th day of July, 1994, my office received a copy of the Petition of Donovan D. Alsleben and Sharon M. Alsleben for the annexation of certain premises located in McLeod County, Minnesota, described as follows, to-wit:

**That portion of the Southeast Quarter of the Northwest Quarter of Section 32, Township 115 North of Range 29 West, situated in McLeod County, State of Minnesota, described as follows: Commencing at the Northwest corner of the Southeast Quarter of the Northwest Quarter of said Section 32; thence South along the centerline of C.R. #25, a distance of 490.0 feet to the point of beginning of the tract herein described; thence East 264 feet on a line 490 feet from and parallel to the North line of the Southeast Quarter of the Northwest Quarter of said Section 32; thence North 160 feet; thence East 33 feet; thence North 330 feet to the North line of the Southeast Quarter of the Northwest Quarter of Section 32 and 297 feet from the Northwest corner of the Southeast Quarter of the Northwest Quarter; thence East along the North line, a distance of 203.0 feet; thence South a distance of 556 feet on a line 500 feet from and parallel to the centerline of C.R. #25; thence Westerly on a line parallel with the North line of the Southeast Quarter of the Northwest Quarter of Section 32, a distance of 500 feet to the centerline of C.R. #25; thence North along said centerline of C.R. #25, a distance of 66 feet, more or less, to the point of beginning.**
