PETITION FOR ANNEXATION

TO THE COUNCIL OF THE CITY OF CAMBRIDGE, MINNESOTA:

THE UNDERSIGNED, being all of the owners of the territory hereinafter described, hereby request and respectfully petition the City Council of Cambridge, Minnesota to annex this territory to the City of Cambridge and to extend the City boundaries to include the same, and for that purpose respectfully state:

1. That the territory to be annexed consists wholly of land which does not exceed 60 acres in area. Your Petitioners own all of the property hereinafter described. Said lands are unplatted. That all of said lands lie entirely within the Township of Isanti, in the County of Isanti, and State of Minnesota, and the description of said lands is as follows, to-wit:

The Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4) of Section Six (6), Township Thirty-five (35), Range Twenty-three (23).

The above-described parcel consists of approximately 42.8 acres.

2. That the territory described above abuts upon the City of Cambridge limits in part, along the West and South lines. None of the property is presently a part of any incorporated City, Village or Burough.

3. All of this territory is or is about to become urban or suburban in character.

4. The population of the area is 0.

WHEREFORE, the undersigned respectfully petitions the City Council of Cambridge to include the land heretofore described which is requested to be annexed within the boundaries of the City of Cambridge, Minnesota, and to annex said territory in accordance with Minnesota Statutes, Chapter 414, as amended, or such other statutes in such cases as are made and provided.

IN WITNESS WHEREOF, the undersigned owners of the territory heretofore described have caused this Petition for Annexation to be executed this 27th day of July, 1994.

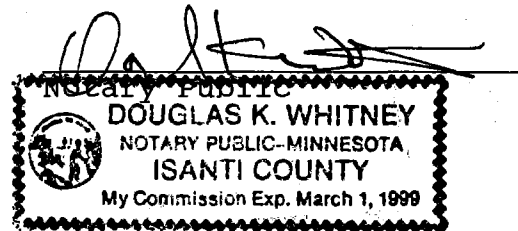

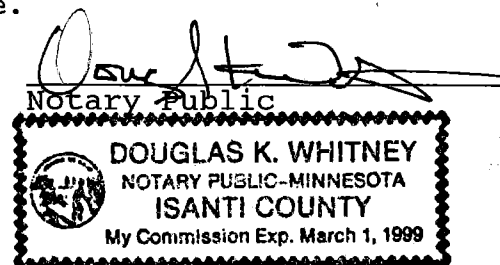
