ORDINANCE NO. 233, 2ND SERIES

AN ORDINANCE EXTENDING THE CORPORATION LIMITS OF THE CITY OF SAINT PETER TO INCLUDE CERTAIN UNINCORPORATED PROPERTY COMPLETELY SURROUNDED BY LAND WITHIN THE LIMITS OF THE CITY

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, this territory is completely surrounded by land within the limits of the City thereof and is deemed to be urban or suburban in character; and

WHEREAS, one hundred percent (100%) of the property owners have requested the City to annex the property described herein.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAINT PETER, NICOLLET COUNTY, MINNESOTA, ORDAINS:

<u>Section 1</u>. Territory annexed. The corporate limits of the City of Saint Peter are hereby extended to include the platted (unplatted) property described as follows:

The North 355.68 feet of the West 210.00 feet of the following described tract:

All that part of the Southwest quarter of the Southwest quarter of Section 9, Township 110 North, Range 26 West, described as follows:

Beginning at the Southwest corner of the S.W. 1/4 of the S.W. 1/4 of said Section 9; thence North 0 degrees 22 minutes East, (assumed bearing) along the West line of the Southwest quarter of the Southwest quarter of said Section 9, 395.68 feet; thence North 88 degrees 44 minutes East and parallel to the South line of said Section 9, 545.21 feet to a point of the westerly right of way line of the abandoned railroad: thence South 8 degrees 42.5 minutes East along said right of way line, 401.55 feet to a point on the South line of the Southwest quarter of the Southwest quarter of said Section 9; thence south 88 degrees 44 minutes West along said South line, 626.05 feet to the point of beginning.

Said tract contains 1.72 acres of land, more, or less, and is subject to Sunrise Drive right of way which contains 0.29 acres, more or less, and is also subject to a 16.00 foot drainage easement the centerline of which is described as:

Beginning at the Southwest corner of the Southwest quarter of the Southwest quarter of Section 9: thence North 0 degrees 22 minutes East along the West line of Section 9 a distance of 40.00 feet; thence North 88 degrees 44 minutes East and parallel with the South line of Section 9, a distance of 104.00 feet to the point of beginning; thence North 0 degrees 22 minutes 00 seconds East and parallel with the West line of Section 9, a distance of 355.68 feet and there terminating.

Section 2. Filing. The City Administrator is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective date of annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.
