ORDINANCE NO. 30

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF RACINE, MINNESOTA

The City Council for the City of Racine, at a special scheduled council meeting, held on June 13, 1994, did consider, review, and act upon a petition for annexation, signed and filed by property owner, Robert Nord of the concerned real estate to be annexed. It appeared to the satisfaction of the City Council, that all appropriate notices as required by Minnesota Laws 1969, Chapter 1146, Section 12, have been met and that the Racine Township is in favor of the annexation of the territory to the City of Racine as evidenced by material with the City Clerk.

The City Council of the City of Racine does hereby ordain as follows: the annexation of the following described land located in the county of Mower, State of Minnesota, to wit:

is and will be for the best interest of the City of Racine and will be and is in the best interest of the territory affected by said annexation, and it is hereby therefore declared that such land be annexed to the to the City of Racine, Minnesota. It is further determined by the City Council that the land to be annexed is now or about to become urban or suburban in character.

This ordinance shall be in full force and effect from and after the passage and publication as provided by law and only after this ordinance is approved by the State of Minnesota Municipal Board as required by Minnesota Law.


