CITY OF BLUE EARTH ORDINANCE NO. 95-8 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BLUE EARTH TO INCLUDE CERTAIN UNINCORPORATED AND UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated the 5th of July, 1995, singed by all owners; and

WHEREAS, no objections to the annexation have been received from the Town Board, or the government body of any municipality whose boundaries abut part of the boundaries of the land to be annexed; and

WHEREAS, other land in the petition abuts upon the city limits at the East and South boundaries thereof except for the Baum building site;

The Council of the City of Blue Earth, ordains:

Section 1 - The City Council hereby determines

(1) That the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and

(2) That none of the territory is now included within the limits of any city.

Section 3 - The territory annexed. The corporate limits of the City are hereby extended to include the unplatted land described in Exhibit "X" attached and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

Section 4 - Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, Secretary of State, Town Clerk, and County Auditor.

Section 5 - Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.
