**ORDINANCE NO. 095-363**

**An Ordinance Annexing Certain Properties Abutting the City of Farmington**

**WHEREAS**, the City of Farmington ("City") received a petition for annexation from all of the property owners of the following described property ("Property"):

The North Half of the Southwest Quarter of Section 29, Township 114, Range 19, Dakota County, Minnesota, EXCEPT the West 100 feet of the East 133 feet of the South Half of the North Half of the Southwest Quarter of said Section 29 and the West 150 feet of the East 183 feet of the North Half of the North Half of the Southwest Quarter of said Section 29 and EXCEPT that portion of the North Half of the Southwest Quarter of said Section 29 lying north and west of CSAH 66.

**WHEREAS**, the Property is located in Empire Township, Dakota County, Minnesota;  
and

**WHEREAS**, the Property abuts the City; and

**WHEREAS**, the area of the Property is sixty acres or less; and

**WHEREAS**, the Property is not served by public sewer facilities nor are public sewer facilities otherwise available; and


**WHEREAS**, the City held a public hearing on November 6, 1995, after providing 30 days written notice of the public hearing by certified mail to Empire Township and to all landowners within and contiguous to the Property; and

**WHEREAS**, pursuant to the procedures set forth in Minn. Stat. § 414.033, the City Council of the City of Farmington may by ordinance declare the Property to be annexed to the City; and






