AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ROSEAU, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING SIXTY (60) ACRES IN AREA ABUTTING UPON THE CITY LIMITS, PURSUANT TO MINNESOTA STATUTES, SECTION 414.033, SUBDIVISION 2(3).

WHEREAS, a certain Petition dated June 13, 1996, requesting annexation of the territory hereinafter described was duly presented to the City Council of the City of Roseau, Minnesota, on the 17th day of June, 1996; and

WHEREAS, written notice, by certified United States mail, was given to the town of Jadis, the town affected by the proposed Ordinance, and to all landowners within and contiguous to the area to be annexed, of a Public Hearing to be held on the proposed annexation on August 5, 1996, at 5:30 PM in the City Council Chambers in the City Municipal Building, 100 2nd Avenue Northeast, Roseau, Minnesota; and

WHEREAS, said Public Hearing was duly held pursuant to said notice on said date and time at said location; and

WHEREAS, the Petition was signed by the sole owners of the real estate described herein; and

WHEREAS, no objections to the annexation were received by the Minnesota Municipal Board, within the time allowed by Minnesota Statutes,

Law Offices Of ATRICK D. MOREN Box 350 Roseau, MN 56751 from the Town Board of Jadis Township, Roseau County, Minnesota, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the city limits of the City of Roseau at the southerly and easterly boundaries and none of the said territory is presently included within the corporate limits of any incorporated city; and

WHEREAS, the territory to be annexed is 60 acres or less.

The Council of the City of Roseau, Minnesota, ordains:

SECTION 1. COUNCIL FINDINGS. The City Council hereby determines that the annexation will be in the best interest of the city and of the territory affected; that the Petition is in proper form and has been signed by the requisite number of qualified persons, that the territory herein abuts upon the city limits and is or is about to become urban or suburban in character, that the territory to be annexed is 60 acres or less, and that none of said territory is now included within the limits of any city.

SECTION 2. POPULATION. The population of the territory is eight (8).

SECTION 3. TERRITORY ANNEXED. The corporate limits of the City of Roseau are hereby extended to include the lands described as

effectually as if it had originally been a part thereof:

TRACT 1-(VATNSDAL)

Beginning at a point on the North line of the Southwest Quarter of the Southeast Quarter (SW1/4 SE1/4), of Section Twenty-four (24), Township One Hundred Sixty-two (162) North, Range Forty (40) West of the Fifth Principal Meridian, according to the United States Government Survey thereof, which point is 784.7 feet East of the Northwest corner thereof; thence at right angles South a distance of 442 feet; thence at right angles Westerly, a distance of 283 feet; thence at right angles Northerly to the North line thereof; thence Easterly, on and along said North line, a distance of 283 feet to the point of beginning, containing 2.87 acres more or less.

TRACT 2-(ROSS)

Commencing at a point on the North line of and 225 feet Easterly of the Northwest corner of the South West Quarter of the South East Quarter (SW1/4 SE1/4) of Section Twenty-four (24), in Township One Hundred Sixty-two (162) North, Range Forty (40) West; thence continuing Easterly along said North line a distance of 276.7 feet; thence at right angles Southerly a distance of 322 feet; thence at right angles Westerly a distance of 276.7 feet; at right angles Northerly a distance of 322 feet, more or less, to the point of beginning and there terminating, containing 2.04 acres, more or less.

SECTION 4. FILING. The City Clerk is hereby directed to file

certified copies of this Ordinance with the Minnesota Municipal Board, the

Secretary of State, the Jadis Town Clerk and the Roseau County Auditor.

SECTION 5. EFFECTIVE DATE. This Ordinance takes effect


