ORDINANCE NO. 390 2ND READING

AN ORDINANCE ANNEXING PROPERTY TO THE CORPORATE LIMITS OF THE CITY OF ALEXANDRIA

WHEREAS, the property owners located within the area described below petitioned the Alexandria City Council to annex this territory to the City of Alexandria, pursuant to Minnesota Statutes Section 414.033, Subdivision 5,

WHEREAS, the petitioner are all the sole property owner within the territory, and

WHEREAS, the territory currently abuts upon the northerly and westerly boundaries of the City limits and none of the territory is presently a part of any incorporated city, and

WHEREAS, the territory is unplatted land containing 0.69 acres and, therefore, does not exceed 200 acres in size, and

WHEREAS, the Alexandria City Council finds the territory can be served with municipal water and is urban in character, and

WHEREAS, the LaGrande Township Board of Supervisors approved the annexation request at a meeting conducted on December 2, 1996.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ALEXANDRIA HEREBY ORDAINS:

That the Corporate Limits of the City of Alexandria are SECTION I. hereby extended to include land as described and the same is hereby annexed and included within the City.

SECTION II. That the territory to be annexed is described by metes and bounds as:

Part of the North 101.32 feet of the East 296.96 feet of the Southwest Quarter of the Northeast Quarter of Section 13, Township 128 N, Range 38 W, Douglas County, of the 5th P.M. commencing at the Southeast corner of said Southwest 1/4 of Northeast 1/4 thence on the record bearing of North along the East line of said Southwest 1/4 Northeast 1/4 a distance of 792.15 feet to the point of beginning, thence leaving said East line and bearing West 296.96 feet, thence South 101.32 feet, thence East 296.96 feet to said East line of the Southwest 1/4 Northeast 1/4, thence North along said East line 101.32 feet to the point of beginning and containing 0.69 acres subject to the existing road easement.

The City Clerk is directed to file copies of this ordinance SECTION III. with the Minnesota Municipal Board, the Douglas County Auditor, the LaGrande Township Board, and the Alexandria Township Board.

SECTION IV. This ordinance shall be in full force and effect from and after its passage, publication, and approval by the Minnesota Municipal Board.
