## PETITION FOR ANNEXATION BY ORDINANCE

## IN THE MATTER OF THE PETITION FOR ANNEXATION OF NORTH RIDGE ESTATES NO. 9 BY THE CITY OF NORTH MANKATO FOR ANNEXATION PURSUANT TO MINNESOTA STATUTES 414.033, SUBD. 5

Petitioners state that the property owner or a majority of the property owners in number are required to commence a proceeding under M.S. 415.033, Subd. 5.

- ▲ a majority of the property owners of the area proposed for annexation to annex certain property described herein lying in the Township of Belgrade to the City of North Mankato, County of Nicollet, Minnesota.

The area proposed for annexation is described as follows:

That part of the Southeast Quarter of the Southwest Quarter of Section 3 and that part of the Northeast Quarter of the Northwest Quarter of Section 10 all in Township 108 North Range 27 West, Nicollet County, Minnesota described as:

Said tract contains 21.81 acres, subject to any and all easements of record.

- 1. There are three property owners in the area proposed for annexation.
- 2. Three property owners have signed this petition. (If the land is owned by both husband and wife, both must sign the petition to represent all owners.)
- 3. The population of the annexation area is 0.
- 4. Said property is unincorporated, abuts on the City's west boundary, and is not included within any other municipality.
- 5. The area of land to be annexed, in acres, is 21.81.
