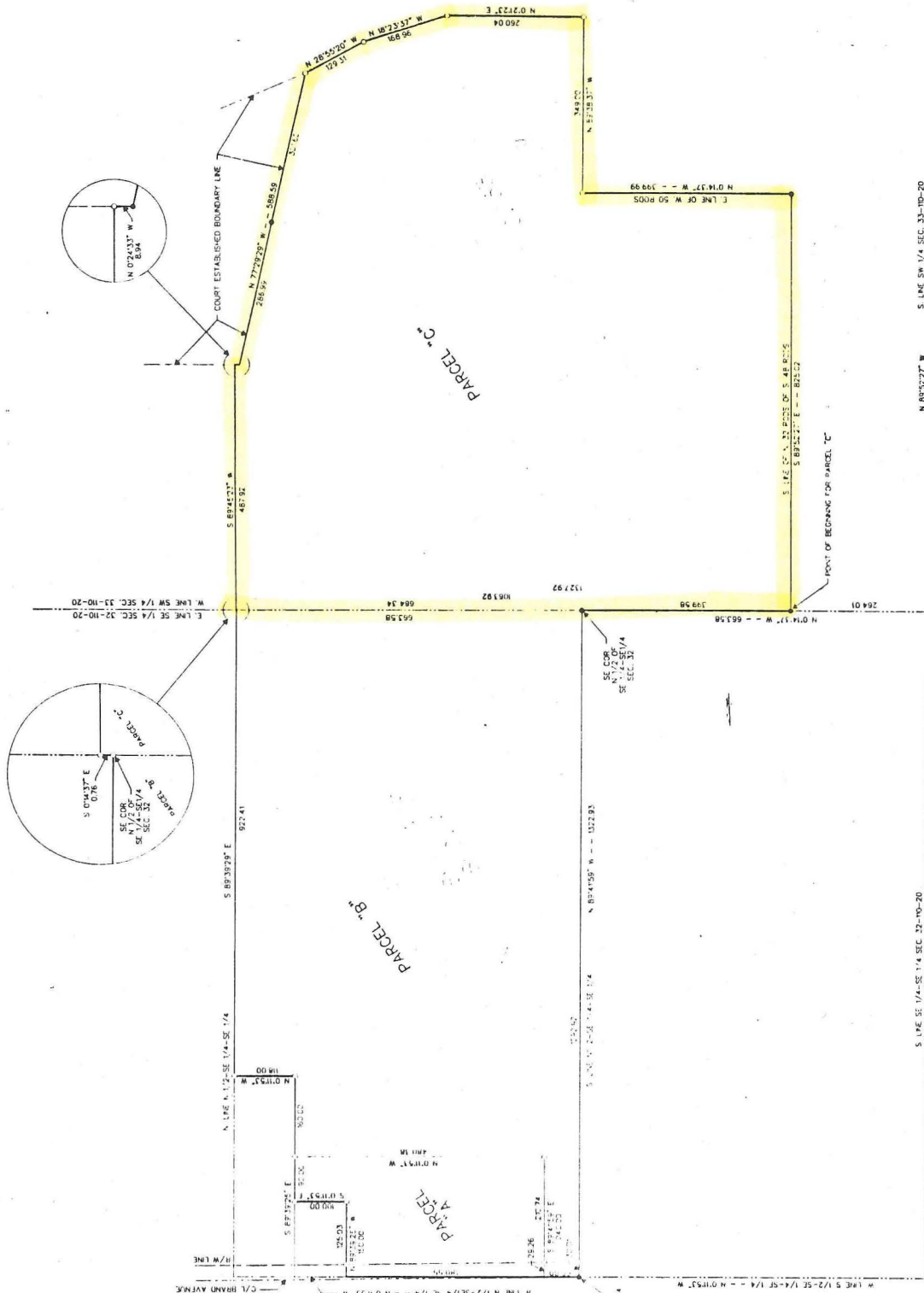
- 1 The territory to be annexed consists entirely of unplatted lands.

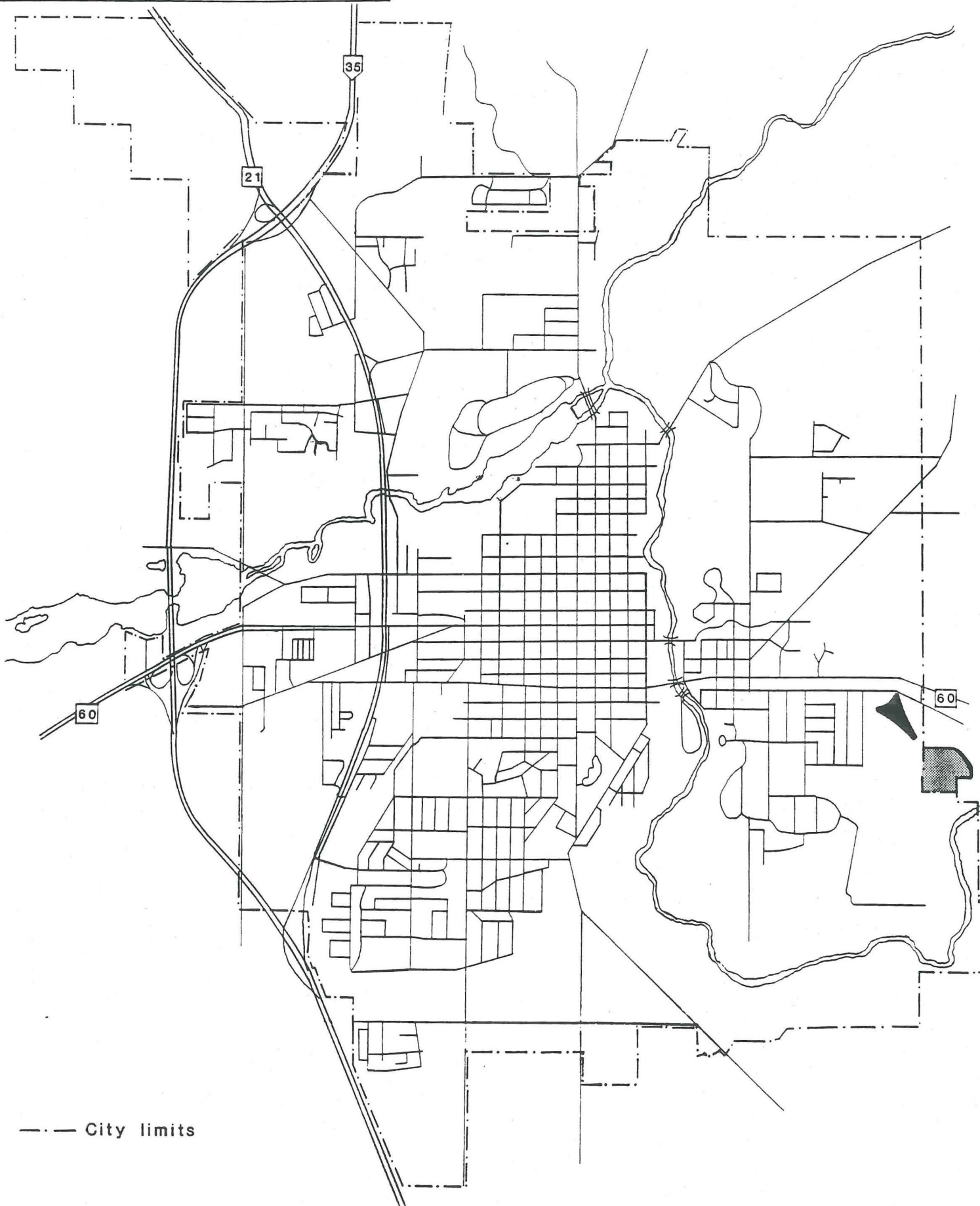
