

RESOLUTION NO

IN THE MATTER OF THE NOTICE OF INTENT
TO ANNEX A PORTION OF DETROIT TOWNSHIP
TO THE CITY OF DETROIT LAKES
(8TH Street Split)

To the Town Board of Detroit Township, Becker County.

WHEREAS, The City Council of the City of Detroit Lakes intends to annex certain territory within the township of Detroit, described as follows:

8th STREET SOUTHEAST AND PELICAN RIVER

THAT PORTION OF THE SE ¼ OF SECTION 26, T139N, R41W, OF THE 5TH PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF VERN ZITZOW'S FIRST ADDITION TO VERN ZITZOW'S RIVERSIDE ADDITION, SAID PLAT IS ON FILE AND OF RECORD AT THE BECKER COUNTY RECORDER'S OFFICE; THENCE SOUTH, ALONG THE EASTERLY RIGHT OF WAY LINE EXTENSION OF PELICAN LANE 649.73 FEET TO THE SOUTH LINE OF SAID SECTION 26, THENCE WEST, ALONG SAID SOUTH LINE 1141.31 FEET, THENCE NORTH, 53.00 FEET TO THE NORTH RIGHT OF WAY LINE OF 8TH STREET SE THENCE WEST, ALONG SAID RIGHT OF WAY 259.28 FEET TO THE CENTERLINE OF THE PELICAN RIVER; THENCE NORTHEASTERLY ALONG SAID CENTERLINE 1296.84 FEET TO THE SOUTHERLY LINE OF SAID PLAT; THENCE EAST 363.51 FEET TO THE POINT OF BEGINNING. BEARING AND DISTANCES ARE MEANT TO TRAVERSE ALONG KNOWN PROPERTY LINES AND STOP AT KNOWN PROPERTY CORNERS. SAID TRACT CONTAINS 15.1 ACRES.

WHEREAS, The above described land is forty (40) acres or less in area and 60 percent or more of its perimeter is bordered by land within the City of Detroit Lakes; and

WHEREAS, The number of households in the above described area is zero and the population is estimated to be zero.



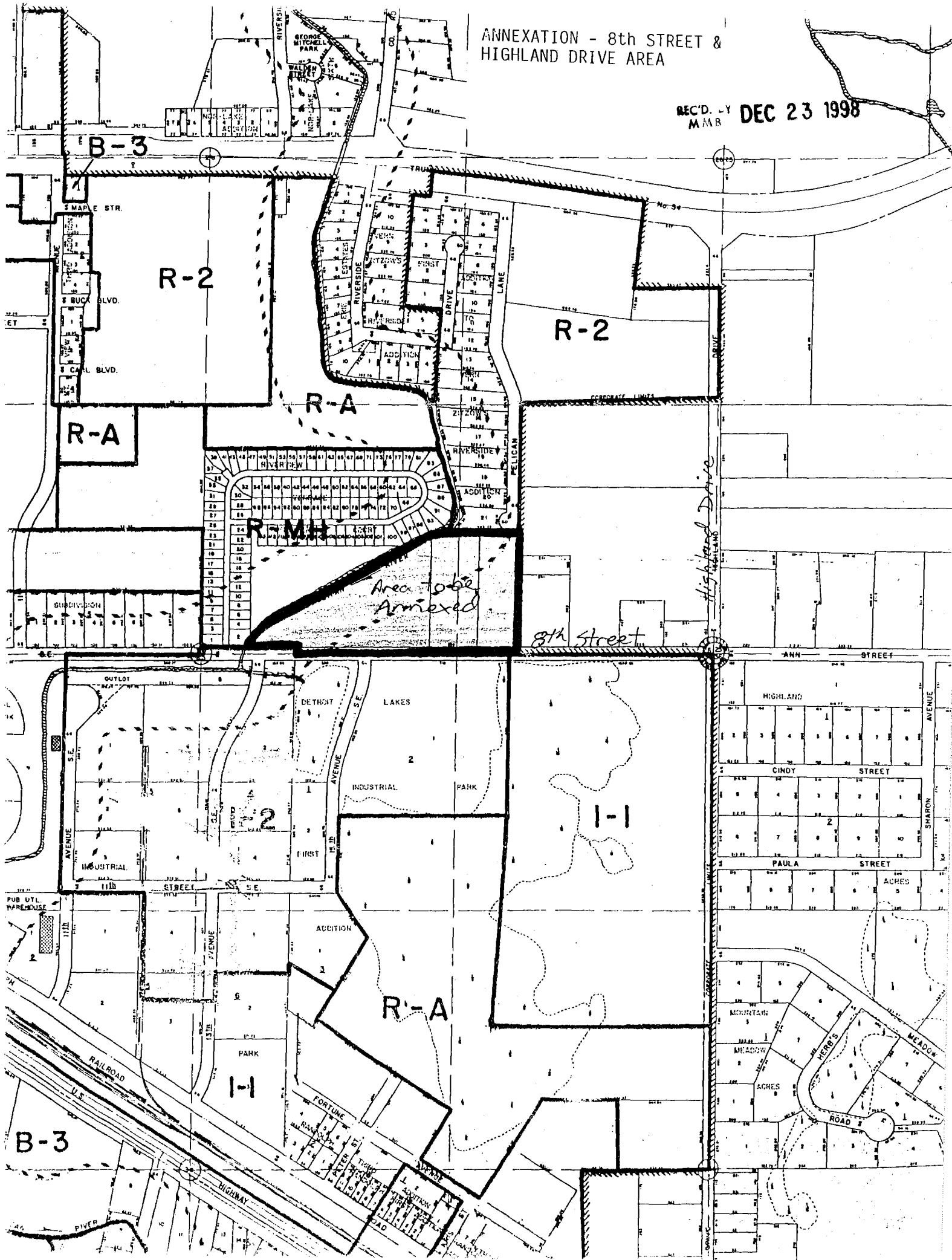
