Re: A-6053 Detroit Lakes (Hwy 34 Zitzow/Erie Estates; 31.3 acres)

Dear Mr. Windschitl:

We have received your letter and enclosures dated March 17, 1999, and regret to inform you that your objections were not timely. While the city resolutions you sent were not signed copies, the December 4, 1998 letter from the City of Detroit Lakes was clear in its notice of the city's intent to annex by ordinance the described property. Further, that letter gives notice of the time in which to file any objections to the annexation. Minnesota Statutes 414.033, Subd. 3 states, "...the municipality shall serve notice of intent to annex upon the town board and the municipal board,..." The city's December 4, 1999 letter complies with the statutory requirement which does not require that a city resolution accompany such notice.

In addition, the Municipal Board sent a letter dated December 15, 1998 to you informing the township of the petition and of the options available to the township including the option of submitting "...written objections to the Municipal Board and to the annexation city within 90 days after the township has received the petition."

Even if the December 4, 1998 letter from the city was not received by the township until December 7, 1998 (the 90-day objection deadline would have been March 7, 1999), the objection filed by the township with the Municipal Board dated March 9, 1999 and received by our office on March 12, 1999 was not received within the required 90 days from the date of service to serve objections with the Board.
