ORDINANCE NO. <u>300</u> 2ND SERIES

AN ORDINANCE OF THE CITY OF THIEF RIVER FALLS, MINNESOTA, EXTENDING THE CORPORATE LIMITS OF THE CITY OF THIEF RIVER FALLS TO INCLUDE CERTAIN UNINCORPORATED REAL PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, The real property described below is not presently within the corporate limits of any incorporated city;

WHEREAS, This real property abuts upon the corporate limits of the City at the west boundary thereof and is deemed to be urban or suburban in character;

WHEREAS, This real property is owned in fee by the City; and

WHEREAS, This real property does not have any population at the present time;

THE CITY COUNCIL OF THIEF RIVER FALLS ORDAINS:

Section 1. Real property annexed. The corporate limits of the City of Thief River Falls are hereby extended to include the platted property described as follows, now owned by the City:

That part of Government Lots One (1) and Two (2), Section Five (5), Township One Hundred Fifty-three (153) North, Range Forty-three (43) West of the Fifth Principal Meridian, described as follows:

Beginning at an iron monument at the northeast corner of said Government Lot 1; thence South 03 degrees 07 minutes 45 seconds West, assumed bearing, along the east line of said Government Lot 1 a distance of 1182.00 feet to an iron monument at the northeast corner of SUNFLOWER SQUARE FIRST SUBDIVISION, according to the Official Plat thereof, on file and of record in the Recorders Office in and for the County of Pennington and State of Minnesota; thence North 86 degrees 52 minutes 15 seconds West along the north line of said SUNFLOWER SQUARE FIRST SUBDIVISION 390.00 feet to an iron monument at the northwest corner of said SUNFLOWER SQUARE FIRST SUBDIVISION; thence South 03 degrees 07 minutes 45 seconds West along the west line of said SUNFLOWER SQUARE FIRST SUBDIVISION 125.00 feet to an iron monument; thence South 86 degrees 52 minutes 15 seconds East along the south line of said SUNFLOWER SQUARE FIRST SUBDIVISION 390.00 feet to the southeast corner of said SUNFLOWER SQUARE FIRST SUBDIVISION at an iron monument on the east line of said Government Lot 1; thence South 03 degrees 07 minutes 45 seconds West along the said east line 53.13 feet to an iron monument at the southeast corner of said Government Lot 1; thence North 88 degrees 07 minutes 51 seconds West along the south line of said Government Lot 1 and continuing along the south line of said Government Lot 2 a distance of 2562.48 feet to an iron monument on the east line of County State Aid Highway No. 16; thence North 02 degrees 47 minutes 41 seconds East along said east line 1314.16 feet to an iron monument on the north line of said Government Lot 2; thence South 89 degrees 09 minutes 02 seconds East along said north line and continuing along the north line of said Government Lot 1 a distance of 2571.58 feet to the point of beginning, containing Outlot A, Block 1, Block 2, and streets within Gilbert Industrial Addition to the City of Thief River Falls, such streets being Greenwood Street and Barzen Avenue; containing 77.65 acres.

Section 2. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Pennington County, the Town Clerk of Rocksbury Township, and the Minnesota Municipal Board.

Section 3. City Code Chapter 1 entitled "General Provisions and Definitions Applicable to the Entire Code Including Penalty for Violations" is hereby adopted in its entirety, by reference, as though repeated verbatim herein.

Section 4. Effective date of annexation. This ordinance takes effect upon its passage, approval, publication, the filing of certified copies as directed in Section 2.






