ORDINANCE NO. 99-3

AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED PROPERTY ABUTTING AND OWNED BY THE CITY OF FAIRMONT, CONSISTING OF APPROXIMATELY 208.40 ACRES, MORE OR LESS

WHEREAS, the City of Fairmont (the "City") has studied its municipal borders and the City's growth patterns; and

WHEREAS, the City desires to promote orderly growth and provide municipal services in an efficient manner; and

WHEREAS, a major agricultural processing facility to be operated by Cenex Harvest States Cooperative Oilseed Processing and Refining ("Cenex Harvest States") will be located on property currently in Rolling Green Township which abuts the City and is currently owned by the City; and

WHEREAS,the Cenex Harvest States facility requires municipal services in order for it to locate in the Fairmont area; and

WHEREAS, the City desires to proceed with the annexation of said property by ordinance pursuant to Minn. § 414.033; and

WHEREAS, the City Council finds that (i) the property proposed for annexation is, or is about to become, urban or suburban in character, (ii) annexation of said property and municipal government is required to protect the public health, safety, and welfare, (iii) annexation would be in the best interest of the property proposed for annexation, and (iv) municipal government will most efficiently provide services to the property.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Fairmont as follows:

Section 1. Property to be Annexed. The corporate limits of the City are hereby amended to include the following property described in paragraphs A through B of this section constituting approximately 208.40 acres, and said property is hereby annexed to and included within the corporate limits of the City pursuant to Minn. Stat. § 414.033 as if such property had originally been a part of the City.

- A. East Track consisting of 100.247 acres as more particularly described on the attached Exhibit A.
- B. West Track consisting of 108.153 acres as more particularly described on the attached Exhibit B.

Section 2. Population of Annexed Property. This property contains a total of 0 households with an estimated population of 0.

<u>Section 3. Zoning.</u> Pursuant to the City Zoning Ordinance, the City designates the property to be annexed in zoning classification I-1.

Section 4. Appropriation of Filing Fee; Authorization to File Ordinance. The amount necessary to pay the filing fee required by the Minnesota Municipal Board for this annexation ordinance is hereby appropriated for such purpose, and the City Administrator is directed to make the necessary filings and provide required information to the Minnesota Municipal Board, the Township of Rolling Green, the Auditor of Martin County, and the Minnesota Secretary of State.

<u>Section 5. Effective Date.</u> This Ordinance is effective upon publication pursuant to the City Charter and approval by the Minnesota Municipal Board.
