TO THE HONORABLE MAYOR AND MEMBERS OF THE CITY COUNCIL OF EAGLE LAKE, MINNESOTA.

The petitioner hereby states:

A. That we, the undersigned, are the sole owners of the properties described as:

The East 295.00 feet of the North 278.50 feet of the Southeast Quarter of the Northeast Quarter of Section 13 Township 108 North Range 26 West, Blue Earth County, Minnesota. Containing 1.88 acres, subject to any and all easements of record.

ALSO, that part of the East 295.00 feet of the Southeast Quarter of the Northeast Quarter of Section 13 Township 108 North Range 26 West, Blue Earth County, Minnesota described as:

Commencing at the East Quarter Corner of Section 13; thence North 00 degrees 15 minutes 59 seconds West (assumed bearing) along the east line of the Northeast Quarter of Section 13, a distance of 714.50 feet to the northwest corner of Lot 10, Block 3, Atwood's Rolling Acres No. 4, according to the plat thereof on file and of record with the Blue Earth County Recorder, thence continuing North 00 degrees 15 minutes 59 seconds West, along said east line, 70 feet to the point of beginning; thence North 89 degrees 56 minutes 54 seconds West, 273.55 feet; thence North 75 degrees 36 minutes 52 seconds West, 22.17 feet to a point on the west line of the East 295.00 feet of the Southeast Quarter of the Northeast Quarter of Section 13; thence North 00 degrees 15 minutes 59 seconds West, along said west line, 244.57 feet to the point of intersection with the south line of the North 278.50 feet of the Southeast Quarter of the Northeast Quarter of Section 13; thence South 89 degrees 45 minutes 04 seconds East, along the south line of said North 278.50 feet a distance of 295.00 feet to a point on the east line of the Southeast Quarter of the Northeast Quarter of Section 13; thence South 00 degrees 15 minutes 59 seconds East, along the east line of the Northeast Quarter of Section 13 a distance of 249.04 feet to the point of beginning. Containing 1.74 acres, subject to any and all easements of record.

B. That the property is unincorporated and is not included within any other municipality.

C. The total area is approximately 3.62 acres.


D. That the reason for annexation is being requested to obtain municipal services from the City of Eagle Lake.
